The Provincial Department of Environment and Conservation has referred an application to the City requesting comment for a Crown Land Grant regarding the above-referenced property. This parcel of Crown Land fronts Thorburn Road and measures 20.12 metres in width and 600.0 metres in length (deep). As part of the subdivision design, the applicant has allowed for a 15 metre road access to the property which design has been approved by the Departments of Engineering and Planning. The remaining 5.12 meters width of former right-of-way has been incorporated into the subdivision design and will be consolidated with the 30.165 hectares of free hold property for potential future development.

An application has been submitted to the City to occupy the subject building for the purpose of a law office. The proposed business will occupy a floor area 136 m² and will require on-site parking for five (5) vehicles. The existing parking area can accommodate two (2) conforming parking spaces and metered parking is available on the fronting street.

The subject property has had continuous commercial occupancies over the life of the building. A physiotherapy clinic, professional engineering offices are some examples of those occupancies.

The property is situated in the (RM) Zone where an Office is a Permitted Use subject to compliance with the requirements of the St. John's Development Regulations. Except for the off street parking requirements, this development does meet all other requirements for development in the (RM) zone.

Section 9.1.2(1) of the Development Regulations provides that Council may relieve an applicant of all or part of the parking required under Section 9.1.1 provided that the applicant is able to show that because of the particular characteristics of the Development the actual parking requirements within the foreseeable future are expected to be lower than those required by City Standards.

Recommendation

An application has been submitted to the City to occupy the subject building for the purpose of office use for an engineering consulting firm. The subject property is considered a Non-Conforming Use under Section 7.12 of the St. John's Development Regulations and has had a history of numerous occupancies including office for several decades, most recently The Bookery, a retail store. The proposed office will occupy a floor area of 125 m² and requires four (4) parking spaces under Section 9 of the Regulations. Parking is not available on the subject lot where Anderson House is located.

Adjacent to this site is privately owned vacant lot which can accommodate ten (10) vehicles and is frequently used by area residents and employees/clients who previously occupied 40 Power's Court. On-street parking is allowed on Signal Hill Road near the site.

The Development Committee supports the change of occupancy as presented. Except for the off street parking requirements, this development does meet the criteria of Section 7.12.4 of the Development Regulations, Change of Non-Conforming Use.

Section 9.1.2.(1) of the Development Regulations provides that Council may relieve an applicant of all or part of the parking required under Section 9.1.1 provided that the applicant is able to show that because of the particular characteristics of the Development the actual parking requirements within the foreseeable future are expected to be lower than those required by City Standards.

Recommendation

It is the recommendation of the Development Committee that Council approve Parking Relief in accordance with Section 9.1.2 of the St. John's Development Regulations for Newfoundland Energy Services Ltd. It is further recommended that approval be given for the proposed office use subject to all applicable requirements of the Department of Building and Property Management.

BACKGROUND

The Environmental Services Division has been working on a night time water main DMA (District Metered Area) study with G + M Consulting for the past few weeks. One of the objectives of this study is to identify water system leaks.

A major leak has been identified in the Austin Street water main. The leak is located in an area where a previous leak was repaired several years ago. The ductile iron water main in question is buried very deep (5 - 6 m deep) and is routed under a former river. Our experience with this type of situation is that the water main is now deteriorating. To make a spot repair now will be expensive and disruptive given the depth of the water main, and will not be a permanent solution. A section of the pipe needs to be replaced with shallower plastic (PVC) pipe.

The quantity of escaping water was measured by flow meter to be 1.44 million litres per day. Based on a production cost of water at the Bay Bulls Big Pond Treatment Plant of 28 cents per cubic metre, the annual purchase cost of this water amounts to \$147,000 per year. Additional distribution system pumping costs are extra.

The estimated cost of the water main replacement is estimated to \$175,000.

Environmental Services currently has a contract in place with Newfound Construction, entitled "2012 Water Main Improvements". The original value of this contract was \$1,166,757. Council has subsequently approved two extensions the contract, ie, extra replacement of water mains on Strawberry Marsh Road (\$350,000) and Waterford River bank stabilization (\$70,000). The approved amount of this contract is now therefore \$1,586,757.

With the contract almost complete, including the added work, we project that we will have approximately \$100,000 left unspent. In addition we have identified \$75,000 of contractual works that was approved in Environmental Services budget 4131 which can be reallocated to this task. Therefore this work can be added to the Newfound contract without the need for Council to allocate any new monies.


