



WDC is the owner of land situated on Shaw Street, in the City of St. John's. Located on WDC's property is a designated Heritage building known as Richmond Hill Cottage (the "Cottage"). In 2011 WDC obtained approval to develop this land on the condition that the Cottage be restored in accordance with the Heritage Advisory Committee recommendations. The development of Shaw Street has proceeded, however WDC has not restored the Cottage as was intended.

Since that time, vandalism and water damage have caused further deterioration of the building. WDC now wishes to demolish the Cottage in favour of a new build. As there was no binding obligation to enforce mandatory restoration of the Cottage, a compromise was established whereby WDC agreed to list the Cottage for sale for a finite period of time as a Heritage home to be restored by a purchaser.

The MOU stipulated a deadline of May 1st, 2017 for a purchase and sale agreement to be entered into between WDC and a purchaser. This deadline has passed and there is no purchase and sale agreement in place. The Legal Department have advised that WDC has met its obligations under the MOU.

I write with respect to the Federal Government's proposed legalization of marijuana in July of 2018 [Bill C-45 an Act Respecting cannabis and to amend the Controlled Drugs and Substances Act, the Criminal Code and other Acts (the Cannabis Act)]. The production, distribution, sale and use of marijuana will require all levels of government to work together to establish a regulation regime.

The City's jurisdiction and powers are granted by the City of St. John's Act and other provincial statutes. Currently, there is no legislative authority for the City to regulate the production, distribution, sale and use of marijuana. We are currently doing a jurisdictional review of other municipalities in Canada to see what action is being taking in anticipation of the Federal legalization of marijuana in 2018. However, our legislative regime is prescriptive, which restricts our ability to regulate, as opposed to many other jurisdictions in Canada with broader enabling legislation.

We would very much appreciate your input as to how you intend to amend or create provincial legislation or implement policies and procedures to deal with Bill C-45. We would be pleased to participate in any consultations, formal or informal, that you may conduct with stakeholders in this matter.

I would be happy to discuss this matter further with you or your officials at a convenient time.

Discussion – Background and Current Status:

Council during its Regular Meeting of April 3, 2017, awarded the contract for voters list management to Datafix-Comprint Systems Incorporated (DCSI) for \$75,260.00 taxes not included. Subsequently, DCSI approached the City to ascertain our interest in providing additional VoterView modules as noted below. These modules would be beneficial to voters, candidates and election workers alike.

1. Online Voter Services (formerly IVL) - \$2,900

The Online Voter Service provides an interface for electors to find out if they are on the voters' list, obtain information about their voting locations (where applicable), and learn about their candidates. This module was formerly known as the internet voter look-up made available to the City in previous elections as a standard option. It is now available only as a separate module with additional enhancements as noted above.

2. Online Voter Registration \$3,200

The Voter Registration module extends the Online Voter Services functionality, by enabling electors to register online to have their name added to the Voters' List. This would enhance voter registration by making the process more accessible and convenient for eligible voters who otherwise would not have the time to register in person at City Hall or at a satellite drop off center. As well, such data is securely encrypted on a site maintained by Datafix, the leading professionals in this field.

3. Candidate Access - \$2,500

The Candidate Access Portal offers controlled access for candidates to view elector list data that is applicable to their ward or overall constituency. With the Candidate Access Portal, <u>www.candidateaccess.ca</u>, candidates can view real-time data for eligible electors via a basic search capability. Providing candidates with real-time data on the voting status of electors is not only a real benefit to candidates but also to election workers who will no longer have to send numerous daily reports to each candidate. The web-based portal would also be available seven days a week, 24/7.

The total cost for all three modules is \$8600 excluding taxes. Should Council be interested in purchasing all three, DCSI has offered a one-time discount of \$2100 for a total purchase price of \$6500 plus tax.
