The Regular Meeting of the St. John's Municipal Council was held in the Council Chamber, City Hall at 4:30 p.m. today.

Deputy Mayor Ron Ellsworth presided.

The subject property is located in the CCM Zone where a dwelling unit on the 2<sup>nd</sup> or higher floors is a permitted use, and a dwelling unit on the 1<sup>st</sup> floor of a building is a Discretionary Use. Parking will be provided via in-house garage and accessed from Long's Hill.

#### 1. <u>Blackhead Road @ Linegar – Concern about safety of intersection</u>

While the Committee, at its last meeting, recommended status quo on this matter, a subsequent Council Directive requested that consideration be given to a traffic calming measure (i.e. speed cushion) for motorists travelling north on Blackhead Road leading up to the intersection, even though it does not meet the warrants as required by the TAC Guidelines.

Discussion took place with staff suggesting it is time for a review of the policy for traffic calming. Staff believes this intersection should be considered. It was also suggested that a reconfiguration of the intersection be explored.

#### **Recommendation**

The Committee recommends as follows:

a. Staff to consider the placement of Blackhead Road @ Linegar Avenue intersection on the traffic calming list;

- **b.** Staff undertake a review of the traffic calming criteria for consideration of the Committee;
- c. The Engineering Department be requested to prepare a cost estimate for a redesign of the intersection for improved function.

# 2. Request for Residential Permit Parking 111-117 Carter's Hill

The Manager of Traffic made reference to an email from the resident of 111 Carter's Hill for permit parking for which staff have conducted a survey on neighboring residents, all of whom are in agreement of this arrangement.

# **Recommendation**

The Committee recommends that residential permit parking be installed on the west side of Carter's Hill at Civic #111-117.

# 3. Letter from Cathy Bennett, MHA re: Speeding on Airport Heights

The Manager of Traffic noted that speeding is a matter of enforcement provided by the RNC. Airport Heights has already been assessed and prioritized for traffic calming and a deferral of further action is recommended based on the implementation of the already approved reduced school zone speed limit this fall. Therefore, staff recommends referral of speeding to the RNC for enforcement.

# **Recommendation**

The Committee recommends referral of speeding on Airport Heights to the RNC pending implementation of the reduced school zone speed limit in the fall of 2015 and that the MHA be advised of Council's decision and the process/criteria for traffic calming.

Discussion took place on feedback signs and the RNC and staff reporting that data collected from these signs can be used in determining the effectiveness of the sign. The signs default to "stealth" mode when power is low but will still collect and store data.

#### <u>Recommendation</u> That staff provide the Committee with summary statistics from the traffic feedback signs.

Superintendent Boland informed the Committee that the RNC's Operation Ringtone has concluded and it has resulted in approximately 1,000 tickets being issued in the metro region. Another operation is scheduled to commence within the next two weeks which is intended to address speeding and aggressive driving. The Committee commended the RNC on these initiatives.

# 4. <u>Pedestrian Safety Suggestions re: Thorburn Road @ Mount Scio</u>

The Committee considered an email from the resident of 88 Seaborn Street which suggests a review of the synchronization of the pedestrian and traffic lights and also brighter paint on the pedestrian walkway.

The Director of Roads and Traffic advised that a leading pedestrian phase at the signal on Thorburn @ Mount Scio has been installed. The Committee was also informed that staff will be using thermoplastic pavement markings at some crosswalks this year to assess its durability. The use of "zebra" marking will also be explored for intersections such as this one with a history of motorist non-compliance with pedestrian crosswalk use.

# **Recommendation**

The Committee recommends that the Manager of Traffic provide the Committee with a list of proposed locations where thermoplastic markings will be used on City crosswalks.

# 5. Rotary Drive/Welland Street - speeding

The Committee considered correspondence from a resident of Rotary Drive advising of her concerns about speeding. Additional correspondence from a resident of Welland Street puts forth the concern of increased traffic that is now using Welland because of the "No Left Turn" restrictions on Blackmarsh Road at Empire Avenue and at Jensen Camp Road. Both restrictions were installed to address the issue of short-cutting traffic through the neighborhood including Rotary Drive.

While the Traffic Division has not conducted a traffic count on Welland Street, it is likely that volumes have increased as motorists have likely found their way onto the street to bypass the turn restrictions. It was originally anticipated that the restrictions would be lifted when/if traffic volumes in the area diverted onto the new Bypass or when traffic calming was installed on Rotary Drive. A recent update of the traffic calming score for Rotary Drive has moved it up the list to number three in the rankings, and with the current funding availability we could proceed with the development of a traffic calming plan for the street. Diver feedback signs were installed on Rotary Drive in early February, and this should have an impact on driver speeds.

# **Recommendation**

# The Committee recommends the following:

- a. Considering ongoing concerns about speeding and the high ranking on the traffic calming priority list, the Traffic Division proceed with the development of a traffic calming plan for Rotary Drive for this coming year; and if approved,
- b. Considering ongoing concerns about higher traffic volumes and speeding on Welland Street, and ongoing complaints from area residents about the inconvenience of the "No Left Turn" restrictions on Blackmarsh Road and with the recent installation of driver feedback signs on Rotary Drive, approval be given for the removal of the restriction on Blackmarsh Road.

# 6. Request for Residential Parking 61-73 Signal Hill Road

The Committee reviewed a request from a resident on Signal Hill Road requesting the installation of permit parking at 61-73 Signal Hill Road. The request was supported by a petition signed by area residents.

# **Recommendation**

The Committee recommends that residential permit parking be installed on the east side of Signal Hill Road at Civic numbers 61-73.

# 7. <u>Request for Feedback Sign – Birmingham Street</u>

Councillor Tilley requested a feedback sign on Birmingham Street in the area of the park, particularly during the months of June to October when the park is frequented by children playing ball.

# **Recommendation**

As Birmingham Street does not meet the warrant for traffic calming, the Committee recommends referral to the RNC for use of its sign and concurs with the RNC suggestion that the RNC undertake a safety awareness campaign (including distribution of pamphlets) with the St. John's Minor Baseball.

# 8. <u>Traffic Congestion – Tim Hortons/Kidcorp Learning Centre – Torbay Road</u>

Councillor Breen informed the Committee of complaints being received from the owners of Kidcorp Learning Centre on Torbay Road. This business has shared parking at the Tim Horton's lot and parents of the learning centre claim they are often unable to safely drop off/pick up their children and in so doing are experiencing extreme delays. It was also reported that the volume of traffic at this Tim Horton's location is causing major congestion on Torbay Road. It was noted by staff that this arrangement is likely part of a development agreement for which it may be difficult to impose restrictions on either party.

Reference was also made to the traffic congestion at the Tim Horton's site on Portugal Cove Road in spite of a double lane that was installed to collect customers.

Some Councillors fear that the proposed Tim Horton's on Blackmarsh Road will result in the same traffic congestion.

# **Recommendation**

The Committee recommends that staff initiate a discussion with the owners of Tim Horton's in an effort to address traffic congestion in the above-noted locations.

#### 9. Inventory of Speed Cushions

Councillor Galgay questioned the inventory of speed cushions and asked if they can be rotated throughout the City in areas of concern. The Manager of Traffic reported there is no rotating program for speed cushions and it is very labour intensive. Given the intent of these cushions to slow traffic, they have to be strategically placed in groups.

#### **Recommendation**

The Committee concurred with staff's recommendation to install speed cushions as a traffic calming measure on roads where staff deems appropriate with Rotary Drive and Mundy Pond Road as potential locations.

Various members of Council spoke in support of the report. Councillor Galgay referenced item # 9 of the report and requested that the issue of speed cushions be referred to the Audit & Accountability Standing Committee for review, particularly in relation to the number of speed cushions in the City's inventory and the percentage of them that are regularly in use. His concern was to ensure that speed cushions are used to their maximum capacity and not laying idle in storage. Councillor Collins also questioned if speed bumps could be installed for downhill traffic rather than across the entire road, particularly for areas with steep inclines which encourage some drivers to speed downhill.

#### The motion being put was carried unanimously.

Department of Planning, Development & Engineering File No. INT1500012 Proposed Relocation of Foundation 100 Paradise Road Town of Paradise Broad Cove River Watershed (W) Zone It is recommended by the Development Committee that Council approve the relocation of the foundation and sub-sequential dwelling pursuant to the Watershed Agreement between The City of St. John's and the Town of Paradise as the proposed concurs with Section 2 of the agreement which states that a replacement shall not cause any detrimental effect on water quality of the watershed and shall remain subject to the provision of the Section 104 of the City of St. John's Act. As per Section 104 (c), a building to replace an existing building destroyed by fire or an existing building dilapidated 50% or more may be permitted by Council.

### 2. Department of Planning, Development & Engineering File No. DEV1500060 Proposed Parking Relief for Dental Clinic Civic No. 484-490 Main Road – Ward 5 Commercial Neighbourhood (CN) Zone

It is the recommendation of the Development Committee that the existing thirty-eight (38) parking spaces will be sufficient for the proposed clinic as well as the existing businesses, and that parking relief be granted.

### 1. Request from Metrobus re: Wheelchair Accessible Service

The Committee welcomed Judy Powell and Jason Hussey to the meeting and considered a request from the General Manager of Metrobus dated April 6, 2015 requesting consideration for funding to ensure that bus stops, shelters and sidewalks are accessible in phasing in a wheelchair accessible service.

Immediate funding required is estimated at \$218,000 which will facilitate the introduction of wheelchair accessible service beginning on June 29, 2015 and the achievement of 90-95% of the bus stops on routes 1,2, and 3 meeting the requirements of an ALF Standard Bus Stop by 2018. It was noted that these routes comprise more than one third of all bus routes serviced by Metrobus.

#### **Recommendation**

Moved by Deputy Mayor Ellsworth; seconded by Councillor Collins : That Metrobus be instructed to commence work on the immediate requirements to advance accessible transit routes for readiness commencing in June 2015, with the understanding that the City will

absorb any potential shortfall of this project in 2015. Further, that staff of Metrobus meet with senior City staff in an effort to identify work that can be carried out internally resulting in cost savings. On the basis of these discussions, the Committee will then be provided with an update of the funding required between 2016 and 2018 to complete the project.

# 2. Memorandum from Deputy City Manager of Community Services re: Parking Fees for Bagged Meters in the Downtown Area

The Committee reviewed a memorandum dated April 8, 2015.

It notes the current rate charged for bagging City of St. John's meters is \$15.00 per day, including HST. The rate established is based on 100% occupancy of the meters, which has been the benchmark for determining the rate for many years. There is no consideration in the rate for lost revenue due to parking tickets. The meters are dedicated spaces for those who rent them, and in many cases the spaces are needed for event and/or construction purposes.

The following information is provided to Council in consideration of adjusting the existing rental rates:

- The rate has been in place for many years.
- The rate is the same that the public would be charged should they park on a meter, thus providing consistency and fairness.
- There is a benefit to the user to have a dedicated space no concern for ticketing, and the ability to come and go as you please without worry of having the space available when you return.
- It is generally not good business practice to utilize existing revenue to determine rates. By using this average approach, if people discontinue to park downtown we will charge less for bagged meters further driving down revenues. In addition, there is an inconsistency in revenue based on where the meters are located, and this approach would support different rates for different locations based on demand.
- There is an existing high demand for parking in the downtown area.
- The City increased meter rates to account for the investment in the two new parking garages in the downtown.
- A reduction in rates will have a negative impact on revenues.
- The City's policy should be to establish targeted revenues based on the needs of the City as determined during the budget process.

While the Committee acknowledged the issue of inconsistency (i.e. 10.32 vs 15.00 rates), it also accepted that there are a number of areas in the City where rates are varied depending on circumstance.

#### **Recommendation**

Moved by Councillor Lane; seconded by Deputy Mayor Ellsworth: That the daily bagged meter rate of \$15 be retained in the Downtown Area on the basis of 100% occupancy.

Councillors Galgay and Tilley voted against the recommendation.

### 3. Housing Business Plan – Implementation and Next Steps

Deputy Mayor Ellsworth presented a report that outlined an implementation strategy to address the Affordable Housing business Plan for the years 2014-2017. The plan addressed the following issues and is available from the Office of the City Clerk:

- a. Increase in engagement
- b. Action information
- c. Policy revitalization
- d. Resource access
- e. Capacity building
- f. Innovation leadership

The Committee acknowledged the creation of affordable housing as a key component of its corporate mission and agreed that funds need to be directed to this initiative to keep the project advancing.

In terms funding required at this time, it was noted that \$44,500 is required to undertake the following:

Faith and Housing Coalition	\$2,500
Seniors Housing Research Study dissemination workshop	\$3,500
NLHHN and participant luncheon	\$3,500
Consultants fees	\$20,000
Start-up costs for three housing first rental units	\$15,000

#### **Recommendation**

The Committee recommends approval of the amount of \$44,500 to advance the City's Affordable Housing Business Plan.

# 4. Draft Cash Basis Financial Statements for Year Ended December 31, 2014

# 5. Request from Acting City Manager re: Project Velocity Budget

An application has been submitted by Woodford Sheppard Architecture to Planning, Development & Engineering to develop a four (4)-storey commercial building at Civic No. 372 Duckworth Street.

The subject property is situated in the CCM Zone under the St. John's Development Regulations where the Floor Area Ratio (FAR) is 3.0. The building has a height of 15m and there is approximately a 3.2m change in grade from Duckworth Street and the proposed entrance at Henry Street+. The Applicant is requesting Council to approve an FAR of 4.0 for this development.

Section 10.23.3(a) of the Development Regulations states that:

Floor Area Ratio (maximum) 3.0

In a situation where owning to substantial grade differences on a lot with frontage on more than one public street, a multi-storey building would have a storey higher than 6.0 metres, Council may increase the maximum Floor Area Ratio to 4.0, provided the maximum building height does not exceed 15 metres.

#### **Recommendation:**

It is recommended that Council approve an increase in Floor Area Ratio (FAR) from 3.0 to 4.0 for the commercial development at Civic No. 372 Duckworth Street.

#### 1. Potential Removal from Heritage Area 3 in relation to Proposed Manga Hotel

At its meeting on March 13, 2015, the Committee reviewed the revised design for a 12-storey hotel proposed for the northwest corner of New Gower Street and Springdale Street. The subject property is in the Heritage Area of the St. John's Municipal Plan and in Heritage Area 3 of the St. John's Development Regulations. The Committee was generally supportive of the building design in the context of its neighbourhood; however, requested the City to investigate and report back on the implications and advisability of removing this site from the heritage area. A memorandum dated March 23, 2015 from the Chief Municipal Planner is included with this report, and the Committee recommends approval of the recommendation contained therein as follows:

That the eastern portion of the subject property at 150 New Gower Street (corner of Springdale Street) be removed from the Heritage Area of the St. John's Municipal Plan and be removed from Heritage Area 3 of the St. John's Development Regulations. The western portion of the property, which may be subject to an application in the future, is recommended to remain in the heritage area.

#### 2. Home Charging Station for Electric Vehicles

The Committee considered a letter from the property owner of 53 William Street requesting permission to install a charging station for an electric vehicle on the front of his property. The matter was forwarded to the Committee for review. The size of the unit is 19.7 inches in depth and 5.3 inches in height.

# ST. J@HN'S

The Committee recommends approval of the installation noting that the unit does not permanently disfigure the property and is similar in nature to electrical meters, satellite dishes, etc.

## 3. Heritage Designation of 124 Military Road

The Committee considered a revised Statement of Significance as circulated by the Heritage Officer. The Committee had previously recommended heritage designation of this property which was subsequently approved by Council.

At its meeting on March 13, 2015, the Heritage Advisory Committee reviewed the revised design for a 12-storey hotel proposed for the northwest corner of New Gower Street and Springdale Street. The subject property is in the Heritage Area of the St. John's Municipal Plan and in Heritage Area 3 of the St. John's Development Regulations.

The Committee is general supportive of the building design in the context of its neighbourhood. The minutes of the meeting also indicate:

With regard to the site location which is currently situated within the heritage area, the Committee further recommends that the City's staff investigate and report back to the Committee on the implications and advisability of removing this site from the heritage area.

The present report examines the application, the heritage area, and their effect on one another. It concludes by recommending that the eastern end of the subject property, the site of the proposed hotel, be removed from the heritage area.

#### Application

The proposal is for a modern building with a height of 12 storeys. The rezoning request is to rezone from Residential Downtown (RD) to Commercial Central Office (CCO), which allows a maximum height of 12 storeys (or 10 storeys in a heritage area). Being in a heritage area requires that floors taller than 4 storeys must be set back a minimum of 8 metres from the street line.

The proposed hotel does not block any public view or street-end view as identified in the 2003 report on St. John's Heritage Areas, Heritage Buildings and Public Views (the PHB report).

#### Effect of the Heritage Area

When dealing with an application to rezone and development vacant land, the main effect of the heritage area is to give the City authority for more control over the exterior design of the building than the City would have otherwise. In the present instance, the applicant has made significant

The subject property is in a prominent setting and visible from many locations, including from New Gower Street as drivers enter downtown from the west. The new Fortis building on Springdale Street is similarly prominent, and that building has turned out to have an attractive design; it is not located in a heritage area.

Two provisions of the CCO Zone would work against the approval of the proposed hotel development. They apply to properties that are zoned CCO, are designated as a bonus area for additional height, and are in a heritage area:

- 1. The height limit is 10 storeys rather than 12, and
- 2. Any height above four (4) storeys must be set back at least eight (8) metres from the street line.

In a memorandum to Council's Planning and Development Committee dated February 13, 2015, I raised the issue of 10 versus 12 storeys in the heritage area. The question is: if a 10-storey building is permissible, than why not 12 storeys? The restriction of two (2) less storeys on a tall building would make little difference at street level (unless a public view from higher up was blocked).

The typical height limit in the heritage area is four (4) storeys. This reflects the many 3- and 4-storey older buildings along Water and Duckworth Streets. There are some taller old buildings such as the former Avalon Telephone Company building on Duckworth Street at McBride's Hill, which dates from the 1920s and is seven (7) storeys on Duckworth. Allowing heights up to 10 storeys in a heritage area was to open the possibility of taller new buildings where appropriate.

Regarding a building setback above four (4) storeys, the intent is to prevent excess shadowing or the effect of a building looming over the street. This setback was imposed for the new building at 351 Water Street (the former Woolworth's site). However, for 150 New Gower, the City asked the applicant to keep the hotel as far away as possible from the houses on Pleasant Street. The applicant complied. On such a narrow site, the hotel goes straight up with no designed setback above four (4) storeys. Requiring the setback would likely make the site undevelopable as proposed.

As well, requiring the setback would not improve the situation for the nearby residents, as the rear of the hotel would be just as close to their back fences. From New Gower Street, the front of the hotel would be set back in its higher storeys, but given that New Gower is a 4-lane arterial road, the difference would have little practical impact, even for pedestrians along New Gower or Springdale. In fact, the applicant modified the original design to create restaurant space and large windows along New Gower, making a more inviting building at street level.

#### Previous Expansion of the Heritage Area

Let us look at context. Until 2004, the subject property was not part of the heritage area. As a result of the report on St. John's Heritage Areas, Heritage Buildings and Public Views completed in 2003 by the PHB Group for the City (informally called the PHB report), the heritage area was expanded significantly. The subject property was included as part of the new Heritage Area 3.

The PHB report examined the heritage area to that date, the characteristics of downtown neighbourhoods, visibility, degree of compliance, significant streetscapes, and urban-design criteria,

then recommended the expansion. The report (page 16) states:

Areas that have already been redeveloped such as the existing high-rises are not included in the [proposed] heritage areas. However areas that are obvious candidates for redevelopment because of vacancy or strategic location, such as the old Woolworth building, have been, even if they do not have heritage value at present. The reason is that their redevelopment will have significant impact on surrounding heritage areas.

Thus, one can see the reason for including the subject property in the heritage area. However, at this time, given the proposal before the City, a valid argument can be made to remove it from the heritage area.

There are few vacant sites of such size in the heritage area. Thus, while a change to the boundary of the heritage area could set a precedent, there are not many other properties in the heritage area that have been vacant for so many decades and which are suitable for high-rise development.

#### **Conclusion and Recommendation**

Introducing a tall building in a heritage area can create regulatory problems as well as design challenges. While we do have taller buildings in the heritage area, such as the 1920s Avalon Telephone building at seven (7) storeys, they are not typical.

Given that the HAC has discussed the idea of removing the subject property from the heritage area, and acknowledging that the removal would make certain Planning factors simpler to address, I defer to the wisdom of the HAC in making this recommendation:

It is recommended that the eastern portion of the subject property at 150 New Gower Street (corner of Springdale Street) be removed from the Heritage Area of the St. John's Municipal Plan and be removed from Heritage Area 3 of the St. John's Development Regulations. The western portion of the property, which may be subject to an application in the future, is recommended to remain in the heritage area.

This is provided for the consideration of the HAC.



# Statement of Significance



# **124 Military Road**

#### **Description of Historic Place**

124 Military Road is a wooden, mid nineteeth-century, bracketed three storey Second Empire style building with a mansard roof, two storey bay, and pediment dormers. The designation is confined to the footprint of the building.

#### **Heritage Value**

124 Military Road has been designated for its aesthetic and historical value.

124 Military Road is aesthetically valuable because of its architectural style. The building is also aesthetically valuable because of its prominent location, the end unit row house at the intersection of Military and Rennie's Mill Road. It is an important part of the Streetscape of Rawlin's Cross and surrounding areas.

124 Military Road is historically valuable because of its age and associations with previous occupants. It was constructed around 1890 and predates the Great Fire of 1892, which destroyed a large portion of the city. It was on the periphery of the fire zone of the 1892 Great Fire.

James Augustus Clift was a resident of 124 Military Road. Mr. Clift was a lawyer, insurance agent and political figure throughout his life. He represented Port de Grave from 1889 to 1893 and Twillingate from 1900 to 1919 in the Newfoundland and Labrador House of Assembly as a Liberal. He served in the Newfoundland Executive Council as Minister of Mines and Agriculture from 1904 to 1909 and from 1918 to 1919. He was District Grand Master in the Freemasons. He was named King's Council in 1903.

#### **Character Defining Elements**

All those features that reflect the Second Empire style of architecture, including:

- Mansard roof;
- Two storey bay;
- Narrow wooden clapboard with decorative corner boards;
- Wide flat mouldings;
- Porch detailing;
- Original main door, sidelights, and transom;
- Location of window and door openings;
- Eave brackets;
- Dormers with pediment and decorative detailing; and
- Original wrought iron fencing.

Recently, two individuals have approached the Mayor's office, Councillor Collins and the Archives Division requesting Council name a bridge after Helen Porter who grew up near the then Job's Bridge.

### Background

When Helen Porter grew up in the area in the 1950's the concrete bridge that connected the Southside to Water Street was known as Long Bridge. There used to be a wooden bridge very close to that location that was known as Job's Bridge and was replaced by the Long Bridge in the late 1950's. Long Bridge was closed in the late 1980's with the harbour arterial development, leaving the only vehicle access from Water Street to the Southside Road on the west end of Water Street on what is commonly referred to as Mill Bridge. This concrete bridge was constructed in 1992.

The two individuals involved in this request would like a bridge named after Helen Porter in honour of her life in the neighbourhood.

To quote one of the requestors Regina Best: "Helen Porter has been writing about life on the streets of St. John's with empathy, humour and candour for over 60 years. Helen Fogwill Porter has been an author, activist, feminist, librarian, teacher, and mother. Born in 1930 on the South Side, she is the author of *Below the Bridge (growing up on the Southside)*. Helen grew up at 127 Southside Road East. She stated in the book, "My Southside extended from the Long Bridge in the west to the Imperial Oil premises in the east"; *A Long and Lonely Ride; January, February, June or July;* and *Finishing School;* as well as dozens of short stories, poems, songs, book reviews, columns and social commentaries. She was one of the founding members of the Newfoundland Writers' Guild and is credited with bringing MetroVerse - the display of poetry on city buses - to St. John's. Between 1964 and 1983 she received 15 "Arts and Letters Awards. Central to Helen's writing is her strong belief in the importance of family and the voice of each person. Over the years, Helen has given freely of her time to mentor and encourage countless young writers".



Since Job's Bridge and Long Bridge no longer exist and the bridge on the west end of Water Street is far from where Porter grew up, if Council would like to proceed with naming a bridge after Helen Porter, I would recommend the footbridge that is close to the original location of Long Bridge and is part of the Grand Concourse trail system. It could be named the Helen Porter Footbridge.
