The Regular Meeting of the St. John's Municipal Council was held in the Council Chamber, City Hall at 4:30 p.m. today.

There were present also Deputy Mayor Ellsworth, Councillors Hann, Hickman, Lane, Puddister, Breen, Tilley, Davis, and Collins.

The Deputy City Manager of Planning, Development and Engineering; the Acting Deputy City Manager of Public Works; Acting Deputy City Manager of Financial Management; City Solicitor; Chief Municipal Planner; City Clerk, and Senior Legislative Assistant were also in attendance.

Call to Order and Adoption of the Agenda

It was decided on motion of Councillor Collins; seconded by Councillor Hann: That the agenda be adopted as presented.

Adoption of Minutes

SJMC2015-06-08/265 R It was decided on motion of Councillor Hickman; seconded by Councillor Davis: That the minutes of June 1, 2015 be adopted as presented.

Business Arising

Notice of Motion re: St. John's Property Tax Exemption The St. John's Farmers' Market Cooperative Ltd. By-Law

During the last meeting, Councillor Hann gave the following Notice of Motion:

Take Notice that I will at the next regular meeting of the St. John's Municipal Council move a motion to enact the St. John's Property Tax Exemption – The St. John's Farmers' Market Co-operative Ltd. By-Law which will have the effect of exempting this Organization from the real property tax.

SJMC2015-06-08/266R

It was moved by Councillor Hann; seconded by Councillor Lane: That the St. John's Property Tax Exemption - The St. John's Farmers' Market Co-operative Ltd. By-law be approved as presented.

Council concurred that the Farmers' Market was a phenomenal organization that had finally come to fruition and found its proper home. They further noted local businesses, local services and local products need to be supported.

The Cooperative has pledged to raise \$100,000 to make this project happen and City Staff will be securing major funding from all three levels of government to cover the remaining renovation costs. The market will be managed in conjunction with City staff.

The motion being put was unanimously carried.

Quidi Vidi Village

Council considered a memorandum dated June 4, 2015 from the Director of Planning & Development regarding Quidi Vidi Village – Temporary Moratorium on Development Applications, Council Directive R2013-08-05/18.

It was moved by Councillor Hann; seconded by Councillor Breen: That the temporary moratorium on development applications in Quidi Vidi Village be formally lifted.

Councillors spoke in favour of lifting the moratorium and commended staff for their efforts in this regard. They noted that any new development would have to keep in character with the Quidi Vidi area. The plan is still a work in progress that clearly identifies the rules and regulations.

He requested a curve removal cost estimate for Blackhead Road. Councillor Puddister advised that staff were following up on this request and would report back to Councillor Collins.

Councillor Collins also requested Driver Speed Feedback signs be placed on Blackhead Road @ Linegar Avenue/Jordan Place Intersection. Councillor Puddister asked to refer this request to staff for consideration.

Police and Traffic Committee Wednesday, May 20, 2015 at 12 noon Conference Room A, 4th Floor, City Hall

1. Request for Crosswalk, Basells Road

Staff reviewed a request to place a crosswalk on Bay Bulls Road in the vicinity of the apartment building a vicinity and the statement building a vicinity of the vicinity of the statement building

A traffic study as conducted which included a count of traffic and pedestrian volumes to determine the Transportation Association of Canada's (TAC) guidelines for a safe crosswalk location. The traffic study revealed only 8 pedestrians crossing in the peak hour, which is far less than what is required (15) for the establishment of a safe crosswalk location according to the TAC warrants. It is recommended that a crosswalk not be installed at this location at this time.

Recommendation

The Committee recommends rejection of the request for a crosswalk on Bay Bulls Road at civic #107.

2. Update on Turning Signals, Blackmarsh Road @ Crosstown Arterial

In response to the Council Directive to increase the left hand turning lane time for Blackmarsh Road to head north/east on Columbus Drive, the Committee was provided with a table illustrating the left turn for eastbound motorists on Blackmarsh Road is operating in a satisfactory manner.

Recommendation:

The committee agreed to maintain status quo with respect to the turning signals at Blackmarsh Road @ the Crosstown Arterial.

3. Update on Turning Signals, Mundy Pond Road @ Crosstown Arterial

The Traffic Division has reviewed the possibility of adding a tyr run arrow/phase on Mundy Pond Road for the eastbound left turn.

An assessment was carried out and it was determined to left hand turning signal would have a negative, undesirable impact.

Recommendation

The Committee recommends that the request for a left turn arrow on Mundy Pond Road be denied.

4. <u>NL Terrace @ East White Hills Road</u>

The Manager of Traffic **acc** sed that she had been in discussions with Engineering on the above noted. It was to that any obstacles obstructing sight distance should be removed such as trees, high accuse set. and that parks staff be consulted.

Recommendation:

The Committee recommends that all obstructing trees be removed from the property to improve the sight lines at the intersection of NL Terrace and East White Hills Road and further that the Department of Engineering be instructed to review the possibility of intersection realignment.

5. Request for a Parking Restriction – Allandale Road

The Committee considered an email from a resident of Allandale Road complaining about parking along the upper part of Allandale Road in the vicinity of Pippy Park where people like to walk, ski, snowshoe, walk dogs and pick berries etc. The residents states that vehicles are parked along both sides of the road making it difficult to travel safely along the road, especially for emergency vehicles who would not likely not be able to get through. The resident suggests that the City, in conjunction with Pippy Park should address this problem.

Recommendation:

The Committee recommends that parking restrictions be implemented at the north extremity of Allandale Road but that consideration be given to the construction of a bulb/turnaround as part of the City 3 Capital Works Program. Referred to Finance to be included in Capita Budget.

6. Request for "No Parking Anytime" – Churchill Avenue

The Committee discussed the unavailability of parking at the Technip Centre in Pleasantville which results in an overflow of parking in Churchill Avenue.

Recommendation:

The Committee recommends approval of the installation of a "No Parking" restriction on the north side of Churchill Avenue from Veteran's Road to Alexander Place and further that staff refer the matter of parking to the Development Committee for follow up.

7. <u>Request for Loading Zone – Cookstown Road</u> Consideration was given to an email from Bridges to Hope requesting a "loading zone" space in front of the Bridges to Hope Building located at Civic #37. Recognizing this is a food bank, which clients who are physically challenged attempting to load and off load vehicles, the organization has requested consideration for a loading zone.

The Traffic Division has reviewed the request and notes that approval will result in the loss of one parking space, however with other spaces in the area, the effect should be negligible.

Recommendation:

That approval be given to replace the parking meter space in front of Bridges to Hope on Cookstown Road with a "Loading Zone 8:00 am - 6:00 pm, Monday to Friday" space.

8. <u>Request for "No Parking" Messenger Drive</u>

Consideration was given to a request from Metrobus to have a parking restriction installed in the bulb at the end of Messenger Drive, as vehicles are parking in the bulb creating a problem for busses to maneuver around with construction ongoing.

Recommendation

The Committee recommends that a temporary "No Parking Anytime" in the bulb of Messenger Drive.

9. Impaired Mobility Parking Issue, 22 Signal Hill Road

The Committee was informed that the resident of #20A Signal Hit Koad has an impaired mobility parking permit and meets the requirements for a designated on street parking space, however, she has no street frontage to accommodate a parking space since her residence is located directly behind civic #20 Signal Hill and.

<u>Recommendation</u> The Committee recommends approval of the installation of the impaired mobility parking space on the nerve side of Signal Hill Road, just west of St. Joseph's Lane for the current resident. The space will remain in place for the period of time the resid**Ont** requires it, but will then be removed.

10. Request for Traffic Calming Blackhead Road.

The Traffic Division has screened Blackhead Road for traffic calming as per the City's Traffic Calming Polo and found that the road does not qualify for calming because of the grade on the ord which exceeds the recommended limit of 9%.

Discussion or place on the benefits of reducing the speed limit in the area; however, staff advised that this is not preferred, given the current speed limit throughout the City of 50 km/hr. Other options were put forward, ie. Warning signs for dangerous curve, or suggestion of speed reduction and the RNC's use of speed radars, It was noted that staff should have additional traffic data for the next meeting.


Recommendation Referred to the RNC for additional enforcement.

Councillor Davis advised that he is still getting complaints from residents of Wigmore about the cross walk on Thorburn Road at Mt. Scio.

Recommendation

That the crosswalk on the south leg at the intersection of Thorburn Road at Mt. Scio be removed.

The parade route begins at the NL Power parking lot on Kenmount Road blocking the EASTBOUND CURB lane providing a safe exit for the parade.

A RNC Traffic Services unit will be the lead Police Vehicle. AT NO POINT WILL ANYONE PASS THIS LEAD POLICE VEHICLE UNLESS DIRECTED BY SAID POLICE VEHICLE.

The parade will leave the parking lot turning right onto Kenmount Road in the curb lane.

The parade will then continue east on Kenmount Road until it gets to the intersection of Thorburn Road and Freshwater Road. At this point the parade will switch from the curb lane to the left lane.

The parade will then continue east on Freshwater Road and then make a right turn onto Atam's Avenue by Booth Memorial High School and then stay left and continue down Prince of Wales Street

The parade then continues down over Barter's Hill, across Waldegrave Street and then turns right onto Water Street entering into the left lane immediately after the turn is made.

The parade then continues west on Water Street and continues onto Wood Bridge Road. It continues west on Waterford Bridge Road making a right turn onto Brookfield Road

The parade then makes a left turn onto Topsail Road entering Ne curb lane immediately after the turn is made.

The parade then makes its way west on Topsail Road in the curb lane until it reaches the on-ramp for Kenmount Road East. When the parade enters onto Kenmount **Road** it stays in the curb lane until the next direction change.

When the parade reaches the Brad Gushue on-range it makes a right turn. The parade continues north on the Brad Gushue Highway until the Goldstone Street **S**. At this exit the parade makes a left turn.

Once on Kelsey Drive the parade stays in the curb lane until Wal-Mart. At the Wal-Mart parking lot the parade will enter the second entrance and begin thing into the assigned parking area.





I. Purpose

To provide clarity on the use of the vehicle replacement fund and outline proper controls for vehicle acquisitions.

II. Scope

This policy applies to all City departments.

III. Policy Statement

The fleet replacement fund will be intended as a fleet acquisition fund for both the replacement of old vehicles and the acquisition of vehicles which will expand the City's fleet.

Any department requesting approval to purchase a vehicle outside this fund will require the approval of a business case by the City Manager. This will be facilitated through the Department of Financial Management. The business case prepared should:

- i. Clearly justify the need for the vehicle,
- ii. Identify why the fleet acquisition fund cannot be used,
- iii. Identify the source of funding for the acquisition, and
- iv. Identify the operating budget impacts including reductions in operating expenses where applicable.

All fleet vehicle purchases must be approved by the Manager - Fleet Services to ensure

compatibility with the overall City fleet.

IV. Responsibilities

All departments are responsible to ensure compliance with this policy. The Department of Financial Management will have a stewardship role in its implementation.

7. Non-budgeted Capital Expenditure – Materials Recovery Facility

Consideration was given to a memorandum dated May 19, 2015 from the Manager – Waste and Recycling re: Non-budgeted Capital Expenditure – Materials Recovery Facility. To resolve a dust problem in the Materials Recovery Facility (MRF), seven exhaust hoods, related fans and controls need to be installed. No budget was allocated for these capital improvements. The cost for this capital improvement is approximately \$250,000.

Recommendation

The Committee recommends that Council approve the transfer of \$250,000 from the Robin Hood Bay capital reserve fund to the MRF's budget for capital improvements to allow for construction of the exhaust hoods, fans and controls.

8. Luncheon Meeting – Participants for Governor General's Canadian Leadership Conference (GGCLC) – May 31, 2015

The Committee reviewed a request from Cathy Duke, Destination St. John's, to hold a luncheon at the Housing and Homelessness Network on Sunday May 31, 2015 for the participants of a study tour through the Governor General's Canadian Leadership Conference (GGCLC). The tour includes 20-25 people at an estimated cost of \$500.00

Recommendation

The Committee recommends Council's approval to sponsor a luncheon at the Housing and Homelessness Network for participants of the GGCLC in the amount of \$500.00. The luncheon will take place on Sunday, May 31, 2015.

9. Vera Perlin Society – Request for funding

At a special meeting of Council on April 24, 2015, Council met with Roger Downer and Earl Holwell of the Vera Perlin Society who conducted a presentation on Vera Perlin - Perlin Centre Phase II Extension. The organization advised they hoped to raise \$3 million to implement Phase II of the project, the breakdown of which is as follows:

Government:

•	Federal:	\$500,000
•	Provincial:	\$500,000
•	Municipal	\$250,000

Fund-Raising – Vera Perlin: \$1,750,000

It has been decided that this project meets its cost sharing policy.

Recommendation

The Committee recommends that the Vera Perlin Society project be referred to the 2016-2018 budget for consideration.

10. Roncalli Playground

Councillor Davis inquired about the possibility of funding to increase the size of the Roncalli playground and make it wheel chair accessible.

<u>Recommendation</u> The Committee recommends referral of this matter to the Public Works Standing Committee for follow up.

11. Request for Funding – 12th Annual Shea Heights Folk Festival

Council considered a memorandum dated May 26, 2015 from the City Clerk regarding a request for funding in the amount of \$1200 for the 12th Annual Shea Heights Folk Festival. This event will be held at the Richard Power Memorial Softball Field and the Shea Heights Community Centre from July 16 to 19, 2015. There is no funding available under existing policies for this event.

<u>Recommendation</u> The Committee recommends Council's rejection of the funding request.

12. Canadian Catholic School Trustees Association - CCSTA

The Committee tabled a letter dated May 12, 2015 from the Chair of Canadian Catholic School Trustees Association regarding a request for funding for their National Convention taking place June 11 - 13, 2015.

Recommendation

The Committee recommends Council's approval in the amount of \$750.00 for the Canadian Catholic School Trustees Association Convention.

13. Request for funding for roof replacement at the Hub

An application has been submitted requesting permission to subdivide the above referenced property to construct one (1) single detached dwelling which will front onto Monkstown Road. There currently exists one (1) single detached dwelling on the property, accessed from Rennie's Mill Road. The property is situated in the Residential Low Density (R1) Zone where the minimum lot area for development is 450 m² and the minimum lot frontage is 15 metres.

The proposed lot would not have the minimum lot frontage of 15 metres at the six (6) metre building line as required under the St. John's Development Regulations. In order to accommodate the proposal, Council would need to establish the building line at zero (0) metres.

As well the applicant is requesting consideration for approval of a minor variance under Section 8.4(5) of the St. John's Development Regulations. The proposed will have a lot frontage of 14.3 metres at the proposed building line and will require a 4.7% variance to meet the minimum lot frontage requirements of 15 metres.

The abutting property owners have all been notified of this proposal. We have received a letter of support from one of these residents.

Council has the authority, under Section 8.3.1 of the St. John's Development Regulations, to establish or re-establish the building line for any existing street or service street, or for any lots or individual lot situated thereon, at any point or place that Council deems appropriate and that is not behind the actual line on which any existing dwelling is built. Further, Council has the authority to require that any new dwellings constructed on lots on existing streets or service streets be built on, or at any specific point behind, the building line established or re-established, pursuant to this Section.
