#### **REPORT**

1. Decision Note dated March 7, 2018 re: Automated Garbage Collection – Individuals with Mobility Challenges

Council considered the above noted.

Concern was expressed about the application process being too onerous for people to reapply every three years, particularly if they have a permanent disability. Some members of Council suggested that people who self-identify as having a permanent disability should have the option to be exempt automatically from the automated garbage collection program. Staff advised that from an audit and evidenced based perspective, the City needs to be diligent in its record keeping of such exemptions. The requirement for reapplication is not meant to be onerous but rather, to keep control over how the program is managed, particularly given the transient nature of people, i.e. changing addresses and changes in personal circumstances over time. It was also felt that there was a risk to compromising the integrity of the system if there is not a certification process.

It was suggested that the reapplication process be reviewed as the program unfolds to ensure that it is less onerous. In advance of the three-year renewal, a reminder notification could be sent to individuals asking them to simply reconfirm their status. Staff was amenable to that idea and assured that the process will continue to be tweaked as it progresses.

Members of Council requested that the City continue to engage the public on this matter and their experiences in relation to the use of the automated garbage collection process and to welcome their testimonials in relation to the program.

#### Decision/Direction Required:

A Developer has requested a Declaration of a Development Area and expropriation of land situated on the corner of Blackmarsh Road and Columbus Drive, with the City conveying the land to the Developer.

## Discussion - Background and Current Status:

The Developer acquired numerous properties on Blackmarsh Road to consolidate land for the purpose of a development. The City has already sold City owned land to the Developer in this area to allow for the commercial development.

A title search carried out on behalf of the Developer indicates a title issue on a small portion of landlocked back land required for the Development (as shown in Schedule "A"); The Developer has been unable to locate the owner of this parcel, essentially leaving this parcel as an "orphaned" parcel.

An option the City has undertaken for perfecting title issues for similar situations in the past, so that Development can proceed, is to expropriate the subject parcel of land pursuant to the City's powers in the City of St. John's Act. If there is an individual with a valid claim to the land being expropriated or a portion of it, they will have a right to be compensated. The City will advertise and serve notice in relation to the expropriation. The City will require the Developer to pay to the City funds representing twice the value of the land to be held throughout the process. Given the scenario, it is unlikely that there is anyone claiming this parcel. After 6 years, should there be no claims made, the money received from the Developer would be returned less our costs associated with the expropriation of this land.

In order for the City to have authority to expropriate, Council must firstly declare the area to be a "Development Area" pursuant to section 98 of the City of St. John's Act.

Considering that the developer proposes to develop this vacant land with a new commercial building, it is deemed to be in the best interest of the Public as it will be in keeping with the commercialization of the area and will align with the rezoning to commercial in the past.
