# **Discussion – Background and Current Status:**

The property, a semi-detached dwelling, is situated in the Residential Battery (RB) Zone where only single detached dwellings are permitted, thereby making the building non-conforming.

An application was submitted requesting a 15.12 m<sup>2</sup> extension to the existing dwelling at 6 Middle Battery Road, a 24% increase in floor area. This application has been advertised as an extension to a non-conforming use, to be considered by Council on March 28, 2016.

This property is also located in the Battery Development Guideline Study Area. The Footprint and Height Control Overlay in the study indicates that the property at 6 Middle Battery Road may not be increased vertically or horizontally. However, it also states that if an owner wishes to expand or build in excess of the Overlay, they must demonstrate through a Land Use Assessment Report (L.U.A.R.) that it is an acceptable development.

The applicant has submitted the LUAR in the form of photographs demonstrating the proposed extension to the dwelling. It has been determined that no views will be impacted from this increase.

Title: Shift Optimization - Roads Division, Public Works

**Decision/Direction Required:** Approval of Shift Optimization and Staff Reductions

# **Discussion – Background and Current Status:**

The Roads Division within the Department of Public Works is responsible for maintenance of City owned streets and sidewalks, including such tasks as snow clearing and ice control in the winter season and street cleaning and asphalt / concrete repairs during the summer season.

During the winter season, 3 shifts provide a minimum of 16 hours of coverage per day. If staff are required beyond this time the remaining hours are covered with overtime. This system provides the City with the flexibility to respond to winter snow and ice events in a timely manner.

# **Key Considerations/Implications:**

# 1. Budget/Financial Implications

The proposed shift optimization would result in the elimination of 4 management and 33 unionized positions during the 16 week winter season, as well as 1 management and 10 unionized positions during the summer season.

Included in these staff reductions is the day shift for sidewalk clearing. The existing system has two day shifts for sidewalk clearing and it was felt that the shift could be optimized to retain the same level of service with a reduction in staff. With this optimization there will be flexibility to add operators to the sidewalk clearing operation if and when needed.

With these reductions, each shift will have the minimum number of staff required to snow clear during a winter event. The current practice of using rented trucks, along with the City's fleet, will enable the existing level of service to the City to be maintained.

These changes will save an estimated \$700,000 in 2016 and \$1,350,000 in 2017. Please see tables below.

The option of reducing an entire shift for the winter season was investigated, but it was realized that this option would have reduced the current service level. The Division would not have been able to maintain the City's policy of having one cut on all City streets within 12 hours after a winter event (<25cm), and street widening completed within 24 hours. In addition, snow removal in the downtown area and snow blow back operations throughout the City would be negatively impacted.

The loss of an entire winter shift would also leave long periods of time without any snow clearing staff on duty. All staff would have to be called in for overtime and their availability would not be guaranteed. The other significant risk for this option is operators maxing out their allowable driving time. Regulations currently set a limit of 15.5 hours of driving with a mandatory 8 hours of rest. This would result in the Division being without staff on site for 88 of the 168 total hours per week. The current three shift system leaves 48 hours per week uncovered.

### 2. Partners or Other Stakeholders

The proposed shift optimization should maintain the current level of service provided to residents and businesses within the City.

# 3. Alignment with Strategic Directions/Adopted Plans

Effective Organization / Fiscally Responsible – The shift optimization recognizes efficiencies within the current winter maintenance activities which should allow the City to maintain the current level of service with fewer employees.

The proposed shift optimization will require the elimination of a total of 48 positions. Numerous positions will be made redundant and unionized staff will be provided with bumping options. Depending on the seniority of the employees involved, the staff reductions could affect other divisions within the City as employees exercise their bumping rights.
