Under business arising, Council considered a memorandum dated August 3, 2009, from the Director of Planning regarding the above noted matter.

#### SJMC2009-08-10/456R

It was decided on motion of Councillor Duff; seconded by Councillor Colbert: That the proposed text amendment to the St. John's Development Regulations regarding Building Lines be approved and that the following Resolution for St. John's Development Regulations Amendment Number 461, 2009 be adopted and referred to the Department of Municipal Affairs for Provincial registration in accordance with the requirements of the Urban and Rural Planning Act:

## RESOLUTION ST. JOHN'S DEVELOPMENT REGULATIONS AMENDMENT NUMBER 461, 2009

**WHEREAS** the City of St. John's wishes to make provision in the St. John's Development Regulations to establish Building Lines for Lots.

**BE IT THEREFORE RESOLVED** that the City of St. John's hereby adopts the following text amendment to the St. John's Development Regulations in accordance with the provisions of the Urban and Rural Planning Act.

1. Repeal Section 8.3.1 ("Building Lines and Setbacks") and replace it with the following new section:

#### **"8.3.1 Building Lines and Setbacks**

In all those Zones in the Use Zone Schedule in Section 10 of these Regulations for which the respective Zone Requirements specifically reference this Section, Council shall have the power to establish or reestablish the Building Line for any existing Street or Service Street, or for any Lots or individual Lot situated thereon, at any point or place that Council deems appropriate and that is not behind the actual line on which any existing Dwelling is built. Further, Council shall have

the power to require that any new Dwellings constructed on Lots on existing Streets or Service Streets be built on, or at any specific point behind, the Building Line established or re-established pursuant to this Section."

2. Add a text reference to the Residential-Special (RA) Zone and the Residential Low Density (R1) Zone in Section 10 of the Regulations to indicate that the minimum Building Line for Dwellings on new Streets or Service Streets shall be the minimum Building Line as set out in metres for that particular Zone, while the minimum Building Line for Dwellings on existing Streets or Service Streets will be established by Council under the authority of Section 8.3.1 ("Building Lines and Setbacks").

**BE IT FURTHER RESOLVED** that the City of St. John's requests the Minister of Municipal Affairs to register the proposed amendment in accordance with the requirements of the Urban and Rural Planning Act, 2000.

#### Public Hearing Report – July 30, 2009

Councillor Colbert presented a report on the public hearing held on July 30, 2009, to discuss an application from Richard Cook on behalf of Elaine Hann to rezone land located between Civic Nos. 585 and 599 Southside Road. Council also considered a memorandum dated August 6, 2009, from the Director of Planning regarding this public hearing report. Councillor Colbert advised that the residents raised a number of concerns during the public meeting including flooding, parking and snow clearing. In addition, he noted that there is an issue with a public right-of-way in front of the subject property and the abutting property at 599 Southside Road. He noted that City survey crews had been to the area recently with respect to the right-of-way issue; however, he requested that a decision on the application be deferred to allow staff the opportunity to review the issues raised by the area residents and prepare a report for Council's information.

Councillors Collins and Hickman indicated that the concerns of the residents were very important in the consideration of this application. Deputy Mayor Ellsworth noted that he chaired the public hearing on the previous application to develop eight townhousing units on this site, and the application was rejected because of the same concerns raised by area residents.

## 1. Preparation of the New Northeast Avalon Regional Plan – City's Submission to CBCL Ltd.

The Director of Planning advised that following the Committee's April 29, 2009 meeting with Mary Bishop of CBCL Ltd., the consulting firm engaged to undertake the preparation of the new Northeast Avalon Regional Plan, staff were directed by the Committee to prepare a submission to CBCL Ltd. outlining the City's comments on the preparation of the new Northeast Avalon Regional Plan.

The Committee reviewed at length the draft submission prepared by staff and requested that certain edits to the discussion paper be made as discussed by the Committee with staff.

(Mayor O'Keefe retired from the meeting.)

Following the discussion, it was moved by Deputy Mayor Ellsworth; seconded by Councillor Hann: That the draft submission, including the requested revisions as previously noted, be approved for submission to CBCL Ltd.

The motion being put was carried unanimously.

It was agreed that staff would make the noted changes to the discussion paper and that it would be then sent to Ms. Bishop at CBCL Ltd. and copied to members of Council, the appropriate staff at the Department of Municipal Affairs, and all members of the Regional Plan Review's Leadership Committee and Technical Committee. It was also agreed that the completed discussion paper would be referred to the next Regular Meeting of Council to be held on August 10, 2009.

Note: A copy of the finalized discussion paper is attached for information. This paper has been distributed as agreed to above.

It was moved by Councillor Coombs; seconded by Councillor Hann: That the Committee's recommendation be approved.

Councillors Coombs and Duff highlighted various recommendations contained in the submission to the consultant, CBCL Ltd., including the impact of development outside the urban core and the impact it has had on the City's road network and infrastructure; the need for a unified urban core; the strong support of the City for the Province's protection of agricultural lands; the need for standardized environmental policies; the requirement for a Regional Transportation Plan and a Regional Transit System; and the recommendation for additional staffing levels at the Department of Municipal Affairs to ensure good monitoring of the plan and its implementation in our region.

Councillor Hanlon noted that while the submission was quite comprehensive, it did not contain any recommendations regarding the need for recreational space and play areas. Councillor Duff advised that these things fall under the purview of municipalities rather than the Provincial Government, and as such would not be part of a Regional Plan.

Councillor Collins noted that while he agreed with the majority of the recommendations contained in the submission, he had concerns about the recommendation regarding unserviced development. He noted that it will be difficult to stop future development in abutting municipalities such as Torbay and Bay Bulls.

Councillor Hickman supported the recommendations contained in the submission, noting that the issues of a Regional Transportation Plan and a Regional Transit System are very important.

Following the discussion, the motion being put was carried unanimously.

It was moved by Councillor Colbert; seconded by Councillor Puddister: That the recommendation of the Associate Commissioner/Director of Engineering and the Director of Public Works and Parks be approved and the contracts/tenders be awarded as follows:

- a. Pyramid Construction in the amount of \$529,088.60
- b. LGL Limited in the amount of \$15,588 + HST
- c. **AMEC** in the amount of \$14.851.12 + HST

Regarding the Hydrological Survey tender, Councillor Duff noted that it was her understanding that the purpose of the survey was to measure water levels necessary to sustain fish habitat, which is a requirement of Environment Canada. She noted that this has been an issue for environmental groups for many years, especially the issue of rapid run-off which scours the streambed and the fish habitat, and runs out of the streams very quickly, thereby lowering the water levels. She inquired about the information that the survey would provide and whether the City had a baseline in terms of what the current stream flows were and if any data had been gathered regarding what has happened with stream flows in the City's major rivers over time. She also inquired if the survey data will establish a baseline, what work will actually be done as part of the survey, and what will the survey data be used for.

The Associate Commissioner/Director of Engineering advised that the Hydrological Survey will be geared towards specific rivers in the City that the water reservoirs, which may require control structures, feed into. As an example, he noted that the information gathered could be used in the

future development of Little Power's Pond to augment the Winsor Lake water supply, where a control structure may be required. The hydrological survey would provide information regarding the amount of water that needs to be maintained downstream to sustain fish habitat. He noted that staff are also looking at another river in the west end as well. The amount of work covered under this survey is limited to two streams.

Councillor Duff inquired if the City had ever gathered data to establish a baseline in terms of monitoring the flows in City rivers, i.e. has the flow been increasing or decreasing and how fish habitat is being maintained. The Associate Commissioner/Director of Engineering advised that the City has a series of flow monitoring stations at various rivers which are used to do modeling in terms of sizing structures such as storm systems, bridges, etc. In addition, Environment Canada has a series of flow monitoring stations on many rivers within the City, and the City has access to that data.

#### The motion being put was carried.

#### Robin Hood Bay Re-Engineering Roll-Off Containers for Public Drop-Off Area

#### SJMC2009-08-10/464R

It was decided on motion of Councillor Colbert; seconded by Councillor Puddister: That the additional work required as part of the tender for the Robin Hood Bay Re-Engineering Roll-Off Containers for the Public Drop-Off Area in the amount of \$37,557.76 be approved. The funding for this additional work will be allocated from the Robin Hood Bay Re-Engineering Budget.

#### Flooding - Dublin Road

Council considered a memorandum dated August 10, 2009, from the Associate Commissioner/ Director of Engineering regarding the above noted matter.

#### SJMC2009-08-10/465R

It was moved by Councillor Collins; seconded by Councillor Hanlon: That \$500,000 in funding be approved to replace the section of sanitary sewer between Dublin Road and Portugal Cove Road, and that the work be done this year due to the urgent nature of the problem, and funded from the 2010 Capital Works Budget.

#### **Petition – Noise Pollution on Wexford Street**

Councillor Hanlon tabled a petition from the residents of Wexford Street regarding the disruption to the quiet and peaceful enjoyment of their properties caused by noise pollution from the

operations of Freshwater Auto/Freshwater Suzuki as a result of the installation of rear doors in their building located on Freshwater Road, which backs onto Wexford Street.

The petition was referred to the Department of Building and Property Management for appropriate action.

Councillor Coombs tabled a petition from the residents of Robinsons Place requesting closure of the walkway running between Robinsons Place and the Village Mall parking lot because of ongoing vandalism, property damage, inappropriate behaviour, etc. which is adversely impacting the residents of Robinsons Place.

The petition was referred to the Department of Public Works and Parks for appropriate action.

#### **Phone Poll**

#### SJMC2009-08-10R/466R

It was moved by Councillor Colbert; seconded by Councillor Hann: That the following Phone Poll be ratified:

a. Purchase of Package from ICMA TV to Prepare a Video Showcasing the City of St. John's for the ICMA Conference in Montreal, September 13-16, 2009 at a cost of \$22,600.

Councillor Hanlon inquired about the ownership and use of the video following the completion of the ICMA Conference. The Chief Commissioner and City Solicitor advised that the City will retain the video copyrights and ownership of the raw footage used to produce the video.

The motion being put was carried unanimously.

#### **Economic Update – August 2009**

Council considered as information the August 2009 Economic Update from the Department of Economic Development, Tourism, and Culture.

#### Blackhead Road – Proposed Weather Station Site

Council considered a memorandum dated July 27, 2009, from the Chief Commissioner and City Solicitor regarding the above noted matter.

Councillor Collins noted that the installation of the weather station on Blackhead Road would be beneficial to the residents of Shea Heights and Southside Road as it will provide staff with more accurate information on weather conditions and enable them to provide more efficient and effective snowclearing service. However, he expressed concern that the proposed weather station may impact the view from the adjacent property owned by Mrs. Yetman.

Councillor Colbert suggested that a decision on the matter be deferred so that staff can determine if the proposed weather station will impact the view of the abutting properties. He also inquired if the Shea Heights Beautification Association had been notified of the weather station installation and if they were in agreement with it. The Chief Commissioner and City Solicitor advised that the Manager of Real Estate Services had been in contact with the Association to advise them of the proposed installation and change to the lease agreement.

#### SMJC2009-08-10/467R

It was decided on motion of Councillor Collins; seconded by Councillor Colbert: That the installation of the proposed weather station on Blackhead Road be deferred to allow staff the opportunity to investigate to see if it will cause any sight obstruction for nearby residential properties.

#### 282 Waterford Bridge Road - Gloria Vardy

#### SJMC2009-08-10/468R

It was decided on motion of Councillor Coombs; seconded by Councillor Hann: That the land in front of 282 Waterford Bridge Road, which was the former alignment of Waterford Bridge Road, be sold to Gloria Vardy at a rate of \$2.00 per square foot (approximately \$4,200.00) plus the usual administration fees in HST.

#### **Loblaws (former Memorial Stadium) – Walking Trail**

It was decided on motion of Councillor Puddister; seconded by Councillor Hann: That the acquisition of the walking trail easement from Loblaws for \$1.00 be approved and that arrangements be made to issue a press release and prepare a plaque acknowledging Loblaws' contribution.

Deputy Mayor Ellsworth advised that he had received calls from a number of parents regarding the re-opening of the King George V Soccer facility, and he noted that staff have advised that the facility will not be re-opened this year. Councillor Puddister indicated that there is some flood remediation work that still remains to be done and the insurance claim for the flood damage is still ongoing.

Regarding the easement needed for the walking trail, Councillor Hann acknowledged the good corporate citizenship shown by Loblaws in providing the easement to the City for \$1.00.

#### **Annual Municipal Performance Report**

Council considered as information a letter dated July 31, 2009, from His Worship the Mayor to Mr. Charles Cirtwill, Executive Vice President of the Atlantic Institute of Market Studies regarding the above noted matter.

Councillor Hann expressed his disappointment that the letter to Mr. Cirtwill was not more strongly worded to convey the City's displeasure with the criteria used by AIMS to compare and rank Canadian cities. He indicated that the criteria used did not allow for an equitable comparison between cities. The City of St. John's cannot be equally compared with cities like Vancouver or Toronto in terms of infrastructure and services. He suggested that the City invite MacLean's Magazine to visit the City to interview senior staff and do a fair story.

Council agreed that this matter would be referred to the Economic Development Committee for consideration and discussion.

#### **Robin Hood Bay Landfill**

SJMC2009-08-10/475R It was decided on motion of Councillor Coombs; seconded by Councillor Galgay: That the purchase of land at East White Hill Road from 50424 Newfoundland and Labrador Inc. required for the entrance to the landfill site in the amount of \$71,500.00 be approved.

#### FMC 2015 Conference Bid

Council considered a memorandum dated August 4, 2009, from the Chief Commissioner & City Solicitor regarding the above noted matter.

#### SJMC2009-08-10/476R

It was moved Councillor Duff; seconded by Councillor Galgay: That Council fully endorse the bid by the City of St. John's to host the FCM's 2015 Conference and Exhibition.

- 20 - 2009-08-10

A brief discussion ensued with Councillors Duff, Galgay, Puddister and Hickman speaking about the major benefits experienced by the City in hosting such a large conference. It was noted that this conference was held in St. John's in 2005 and it was a very successful event in terms of economic return to the local economy and tourism exposure.

#### The motion being put was carried unanimously.

#### **Councillor Collins**

- Councillor Collins apologized to Ms. Georgina Maher for comments he made about her during the last Council meeting which were made in the spirit of fun, but which caused her some embarrassment. He noted that she is a good friend who is heavily involved in the community and the residents are lucky to have such a dedicated person working on their behalf.
- Councillor Collins advised that Southlands Family Fun Day was held this past weekend which was well attended. Hopefully, next year the Community Centre will be built and the event can be held there.
- Councillor Collins congratulated the Kelly's Pub Junior All-Stars Softball Team on capturing the gold medal at the 2009 Canadian Junior Nationals in Owen Sound. He noted that several of the players on the team were residents in Ward 5.

#### **Councillor Hanlon**

Councillor Hanlon noted that she had received calls from some constituents regarding the paving work done on Elizabeth Avenue who were concerned about the manhole covers that were still raised and further paving was required. The Associate Commissioner/ Director of Engineering advised that the contractor has laid a base coat of asphalt on Elizabeth Avenue, however, there are still two hydrant connections that need to be installed which requires street excavation. Once this is completed in the next week or so, then contractor will lay the top coat of asphalt.

- Councillor Hanlon referenced the construction work recently completed on Portugal Cove Road, and she inquired if the City had a policy with respect to notifying area residents of the construction schedule. The Associate Commissioner/Director of Engineering advised that it is not Council's policy to advise resident of construction schedules as the schedule may change if it is found that additional infrastructure work is required or the project is delayed due to the weather.
- Councillor Hanlon thanked the participants who took part in Safety Week activities, and she noted that a considerable amount of money was raised for the Brain Injury Association.

#### **Councillor Coombs**

Councillor Coombs tabled a letter from Mr. Jonathan Simon, 56 Amherst Heights
regarding the condition of a portion of City owned land that he has to use to access his
driveway and requesting that the City undertake repairs to this land.

Council agreed to refer the matter to the Department of Engineering and the Legal Department for appropriate action.

Councillor Coombs tabled a letter from Mr. Joe Bennett, Director of Development,
 Bowring Park Foundation, requesting that the City purchase a table for the Black Swan
 Gala Fundraiser taking place on September 10<sup>th</sup>.

#### SJMC2009-08-10/477R

It was decided on motion of Councillor Coombs; seconded by Councillor Collins: That the City purchase a table of 10 for the Black Swan Gala Fundraiser at a cost of \$2,500.00.

 Councillor Coombs referenced the Folk Festival which was held this past weekend at Bannerman Park, and he congratulated the organizers on the success of the event. He noted that on Sunday, there were over 300 people waiting outside the park because the - 22 - 2009-08-10

venue was at its capacity. The organizers have indicated that they will look at expanding the venue for the future.

#### **Councillor Galgay**

- Councillor Galgay referenced the recent Regatta event, and he noted that one of his constituents had an unfortunate encounter when some dogs got into a fight during the event. She became entangled in one of the dog's leashes and fell down as a result. She inquired if it was really necessary to have dogs at such a major event given the heat and the confusion of the crowd. He indicated that he would ask to have the matter referred to the City's Animal Care and Control Committee and the Parks and Recreation Committee for discussion.
- Councillor Galgay referenced the large 100 year-old tree located in the McKee's Grove development off Margaret's Place (the former Belvedere Property) also known as the Wisdom Tree by area residents, and he noted that a huge branch had been broken off the tree, which obstructed part of the roadway. He noted that he had called the Manager of Streets to have the branch removed and to ask that the City Arborist look at the health of the tree.

#### **Councillor Puddister**

- Councillor Puddister congratulated the Regatta Committee on the success of the Royal St.
   John's Regatta. He noted that he had received a call from a constituent commending City staff on the good job that they did in cleaning up after the event.
- Councillor Puddister also referenced the voluntary no-smoking policy at the Regatta, noting that it seemed to be very successful. He indicated he only saw four or five people smoking at the event.
- Councillor Puddister advised that he had spoken to a senior citizen over the weekend concerning parking at the Regatta, and the lack of access to parking for people with

mobility impairments. He noted that the parking lot nearest to the Legion is mainly used by people with campers and recreational vehicles, and he suggested that the Regatta Committee be contacted about restricting campers and recreational vehicles to half the parking lot, with the other half being dedicated for mobility impaired parking. Deputy Mayor Ellsworth advised that it was his understanding that there was mobility impaired parking available at various locations around the Regatta. However, there is no dedicated parking for seniors without disabled parking permits. He suggested that Councillor Hickman, as the City's representative on the Regatta Committee, bring forward the issues of providing seniors parking and dedicating a portion of the parking lot adjacent to the Legion for mobility impaired parking, to the Committee. Council agreed with this suggestion.

#### **Councillor Hickman**

- Councillor Hickman commented on the success of the recent St. John's Time event.
- Councillor Hickman inquired about the timeframe for the completion of the RNC monument project on Queen's Road. The Chief Commissioner and City Solicitor advised that the work on the project is about to commence and should take a couple of months to complete.

#### **Councillor Gerry Colbert**

- Councillor Colbert commented on the success of both the Regatta and the Folk Festival.
   He noted that both events were well attended and a big draw for tourists.
- Councillor Colbert referenced the crosswalk on Adams Avenue in the vicinity of the Ayre Athletic Field. He noted that the crosswalk is not at the entrance to the field, which is where most people tend to cross the street when they are going to and from the field. He asked that the matter be referred to the Police and Traffic Committee for review and investigation.

Councillor Colbert noted that during the last Council meeting, he had requested that consideration be given to using the word "caribou" in the name of one of the new streets in the Pleasantville area. In this regard, he suggested that consideration be given to naming the trail around Quidi Vidi Lake or one of the new trails in St. John's the "Caribou Trail". Council referred this suggestion to the Parks and Recreation Committee for consideration.

Councillor Colbert referenced the old fire station located in Pleasantville, noting that the building has become an eyesore. He asked that staff contact the appropriate Provincial Government Department to request that the building be painted.

#### **Councillor Duff**

Councillor Duff referenced the St. John's Time marketing plan, noting that it will soon be coming up for review. In this regard, she suggested that consideration be given to including those festivals that take place slightly outside the timeframe for the St. John's Time (e.g. Tuckamore Festival, Jazz Festival), in the new marketing plan. Council referred this suggestion to the Tourism Committee for consideration and review.

At this point in the meeting, Councillor Duff assumed the Chair so that Deputy Mayor Ellsworth could give his Notice of Motion.
