



The Arts Jury has acknowledged the challenge to allocate its \$100,000 grants program to the many applicants who have submitted requests totaling almost \$300,000. In this regard, the Arts Jury has agreed to concentrate on original artistic creation over funding to organizations, and with this in mind, the following is recommended:

That the provincial administrative organizations of Music NL and VANL not be given their annual grants of \$2000 and \$1000 respectively. The Jury wishes to express that this decision is not due to the diminished value of these organizations but to the overwhelming demand of requests received.

The Arts Jury has also recommends that:

Major cultural institutions such as the Newfoundland Symphony Orchestra and the Tuckamore Festival be allocated under a separate funding arrangement than that of the Arts Jury. The Arts Jury feels that festival funding in general should be reallocated given the demand they place on the arts grants.

It should be noted that during Council=s Regular Meeting of November 27th, 2006, the following recommendation of the Tourism Standing Committee was approved: That an internal committee be formed to review the funding and in-kind support that is attributed to the festivals occurring within the City of St. John=s with a view to developing a comprehensive criteria and budget through which such funding requests can be channelled. The internal committee will be comprised of staff who have involvement with providing support to festivals.@

This review is currently ongoing, and a report will eventually be submitted to the Tourism Standing Committee.

His Worship the Mayor

His Worship the Mayor referred to a media story surrounding an incident involving a Southlands family who looked for assistance from the City in getting their son to the hospital during a recent snowstorm. The Mayor noted it was an unfortunate situation and explained the circumstances surrounding the incident.

The Mayor referred to an email from the Director of Public Works & Parks on the matter of responding to requests from medical personnel, patients, etc. for snowclearing service in the context of snowstorms which he read into the record as follows:

AWe are sympathetic to these types of situations but there is no practical way for us to assist. We receive dozens of such requests from patients, doctors, nurses, medical support staff, etc. If we were to take equipment off routes to assist all of these people to get to work or appointments, the time frame to get the streets opened would be extended to an unacceptable level.

Another problem, is that we have no way of knowing how many of these situations are genuinely urgent and how many are discretionary. If we provided such a service, it would be wide open to abuse. This is the reason we direct all such callers to the 911 service. 911 is equipped to make a judgement on whether or not it is a real emergency.

Organizations that operate essential services normally make their own arrangements to get staff in to work on storm days.@

His Worship the Mayor pointed out that it is important that the City has standards to apply in dealing with theses calls and noted that he has the utmost confidence in the staff who provide the snow clearing service.

Other members of Council referred to incidents of concern during the recent snow storm such as sidewalk snow clearing in the downtown, abandoned vehicles impeding snow clearing operation, media reporting, etc.

Councillor Puddister

Councillor Puddister congratulated the St. John=s Airport Authority on securing a new airline for the St. John=s to London route and encouraged not only residents of St. John=s but also residents of the North East Avalon to utilize the airline for travel to London.
