

Discussion ensued during which Councillor Tilley tabled a letter from Mr. Michael Doucet, 11 Welland Street, expressing concerns that the development will negatively impact traffic in the area. Councillor Tilley noted he is satisfied with the traffic impact analysis recommendations and is confident the development will significantly benefit the area.

Councillor Hickman presented a petition from residents of the area seeking rejection of the proposed rezoning and development of the Gulliver's Farm Property on Blackmarsh Road, the prayer of which reads as follows:

We the undersigned, residents of St. John's and residents that will be affected by the proposed development, herby request that the City of St. John's reject this application. We are concerned that the plan as put forward proposes a density that is too high in relation to the surrounding area. We are not opposed to development on the site, but feel that it needs to be done within the context of the surrounding neighbourhood. Any development on the site should reflect the local neighbourhood and should be a residential area, or at most, a mixed residential and low-density apartment setting. Given this statement, we encourage the proponent to consider an alternative development plan and application. We also encourage the proponent to seek public input as they develop their plan, to learn the wishes and needs of the nearby citizens that will be impacted by development of the site.

Councillor Hickman agreed with the concerns raised relative to the impact the development will have on traffic and traffic flows in the area. He noted that the notification of the public hearing held on the development should have taken in a wider radius of Cowan Heights. The Director of Planning advising that the notification radius encompassed slightly beyond the 150 m distribution radius requirement under the Development Regulations.

Members of Council supporting the motion felt that the development, which will be phased in, will benefit the area by providing a mixed residential development allowing an opportunity for affordable housing units to middle income residents and those looking to downsize; and agreed that the completion of the east/west arterial and Team Gushue Highway will help alleviate traffic concerns.

# 1. National Geographic GeoTourism Project

The Committee met with Tanya Edwards and Suzanne Dooling with the Canadian Parks and Wilderness Society; Ken Sooley of Cape Race Cultural Adventures and Juanita Keel-Ryan with the Provincial Dept. of Tourism, Culture & Recreation. This delegation conducted a power point presentation on the concept of the GeoTourism project which is being promoted worldwide through National Geographic. The purpose of the project is to sustain and respect the geographic and cultural integrity of tourist destinations by promoting concepts such as adventure tourism, geo-tourism and community stewardship of valuable assets. The City has been approached to consider becoming involved with this initiative which will provide great exposure for tourism possibilities.

# 2. Travel Media Association of Canada Conference 2012

The Committee considered background information from staff with respect to the proposed bid for the Travel Media Association of Canada Conference for 2012. Councillor Hanlon tabled a letter from Sheilah Mackinnon, Secretary Jess's Place requesting waiver of permit fees associated with repair work on Jess's Place facility.

# SJMC2010-02-08/84R

It was moved by Councillor Hanlon; seconded by Councillor Colbert: That permit fees associated with repair work on Jess's Place facility, be waived.

The motion being put was unanimously carried.

Councillor Hanlon tabled an email from a resident concerned about the placement of inappropriate photos on poles in the downtown. The matter was referred to the Director of Building and Property Management for follow-up.

Councillor Hanlon raised the issued of traffic and speeding in school zones referencing a recent traffic accident incident in front of St. Andrew's School. She noted it appears people are unaware of a very safe drop-off location behind the school and encouraged the schools to communicate this to the parents.

# **Councillor Tilley**

Councillor Tilley asked that a letter be forwarded by the Mayor on behalf of Council to the Vancouver Olympic Organizing Committee as well to the Athletes Committee to congratulate them and extend best wishes as they take part in the 2010 Vancouver Winter Olympics.

# **Councillor Galgay**

Councillor Galgay referenced the significant damage caused to the wharves and sheds in Quidi Vidi Village and the Outer Battery due to the blizzard conditions this past weekend. He noted that both he and the Deputy Mayor as a result of a call from some of the area residents, met with a representative group concerning the situation. Councillor Galgay mentioned at the meeting the need to work cooperatively with MP, Siobhan Coady and MHA, Lorraine Michaels to address the issues resulting from the storm damage. He noted that arrangements were made for himself, the Deputy Mayor and a staff engineer to meet on Wednesday, February 10, 2010 at 2:00 p.m. to view the damage. Councillor Galgay also advised that he was informed that a citizens committee will be formed to address not only the issue at hand but to look at the future tourism potential, how to increase tourism, etc., in that particular area.

# **Council Breen**

Councillor Breen noted last week's announcement by the Federal Minister of ACOA of \$350,000 towards the City's Cycling Program, which involves funding a pilot project in the Virginia River Trail, to expand it to accommodate bicycles and pedestrian traffic. He noted that although he supports the cycling plan he has concerns about having bicycles and pedestrians share the one trail in these areas, noting that the Virginia River Trail is heavily utilized by pedestrians including seniors and children. He indicated it is his hope that before the pilot project moves forward that consideration will be given to the installation of distinct trails.

Councillor Breen asked, when possible, that members of Council be apprized prior to such funding announcements, particularly as they relate to a specific Ward.

# **Councillor Hann**

Councillor Hann asked that Council support his request that the Mayor write the Province along with the Eastern School Board requesting that serious consideration be given during upcoming budget deliberations, to move forward with plans for the construction of a high school for the west end of the City. Council concurred.

# **Councillor Hickman**

Councillor Hickman referenced Council's approval to proceed with the proposed rezoning application of the Gulliver Farm Property and asked if measures will be taken to ensure a potential rodent problem is addressed. The Director of Engineering advised that he anticipates that the owner will be required to obtain an environmental clearance in this regard. He agreed to follow-up.

Councillor Hickman also asked if a hydrological study had been conducted on the project. The Director of Engineering advised that storm water management was considered during review of the application.

Councillor Hickman asked the Deputy City Manager and Director of Public Works and Parks to comment on the roll-out of the sidewalk clearing plan following a major storm vs a small/moderate storm.

The Director of Public Works noted that currently the City has two major sidewalks routes to clear and generally, following a small or moderate storm, it takes approximately 7 or 8 days to get through the routes. However, with a storm like the past weekend it takes significantly longer because some sections require removals. He noted that practice has been to start the sidewalk clearing as soon as the snow stops, however, one of the disadvantages of doing that in certain places is spill over onto the sidewalk, while crews are still widening particularly the 4 lane highways. He noted it usually takes a day or two to complete the push back and generally crews clear the routes a second time because of spill over onto the sidewalks. He advised, however, the practice is being monitored and adjustments

may be made in the future, but for this year sidewalk clearing starts immediately after the snow stops. His Worship the Mayor urged residents not to toss snow back onto the cleared sidewalks.

# **Councillor O'Leary**

Councillor O'Leary commended the St. John's Clean and Beautiful Schools Committee and Grade 3 students throughout the City who are hosting an exhibition of their work titled "For the Love of St. John's' to be held at City Hall, Thursday, February 18, 2010.

Councillor O'Leary advised members of Council that she has been invited to serve as a Council representative on the Crime Prevention Committee.

Councillor O'Leary commended Councillor Hanlon on her involvement in the St. Andrews Elementary School issue. She advised she received a call from a concerned parent questioning why the City hasn't assigned a crossing guard at the St. Andrew's School due to the fact it is an area established as a high traffic zone. The matter was referred to the Transportation Engineer for follow-up.

Councillor O'Leary advised she received emails concerning the Councillors' Pension Plan. She will take the matter up with the Director of Finance and City Treasurer, and subsequent referral to the Finance and Administration Standing Committee.

#### **Deputy Mayor Mayor Duff**

Deputy Mayor Duff alluded to the recent storm damage to Quidi Vidi Village and the Outer Battery and indicated she feels the City has a role to play in bringing together the various agencies to look at the possibility of erosion of the shoreline and to find ways to address the situation.

In response to Councillor Breen's comments about the funding announcement for the City's Cycling Project, Deputy Mayor Duff noted that she was asked in the absence of the Mayor to attend discussions on the economy but she was not informed in advance of the details of the announcement. She noted that following

the announcement, she forwarded a copy of the press release and her comments to all Council members.

Regarding Councillor Breen's concerns relative to multi-use trails, she noted that prior to his membership on Council, there was an extensive briefing and public consultation related to the Virginia Trail. She noted there are parts of the trail that will be separated, and parts where there were no alternatives but to widen and multi use them. Deputy Mayor Duff noted that Council made a commitment to involve the Grand Concourse Authority in the design and implementation phase and that there would be full consultation as the project moves along.

There being no further business, the meeting adjourned at 5:50 p.m.
