# **Tim Horton's Drive Thru**

Under business arising, Councilor Colbert referenced the "Cheers and Jeers" Article in the Telegram indicating that according to Section 111.(1) of the Highway Traffic Act, traffic spilling onto roadways is against the law. The Chief Commissioner noted that this section of the Act does not address this particular issue, noting that Council and staff will be meeting with representatives of Tim Horton's next week and is confident a satisfactory resolution to the situation will be reached.

Councillor Puddister noted that contrary to some reporting, the intent of Council's motion of last week that a moratorium be placed on drive-thru applications, is to place a temporary ban on proposed applications to ensure the requirements of the City's traffic Department are met in the interest of public safety. Members of Council took exception to comments made by Mr. Brad George of the Canadian Federation of Independent Business, that the City is not being "business friendly." His Worship the Mayor noted he intends to write Mr. George in this regard.

# Redmond's Road Vehicle Impound Lot

Deputy Mayor Ellsworth asked the status of Councillor's Coombs' query as to whether the Redmond's Road application was discussed at Council's private meeting on November 17, 2008. Councillor Coombs noted that he was advised by staff that the official minutes did not contain reference to this application. Councillor Puddister indicated he incorrently informed Councillor Coombs in this regard and that a brief discussion ensued following adjournment of that meeting.

Deputy Mayor Ellsworth alluded to last week's failed motion by Councillor Coombs, due to lack of a seconder, to have Council's decision of November 17, 2008 allowing the establishment of a Towing and Vehicle Impound Lot located on Redmond's Road, rescinded. He noted the Mayor's expression of "disappointment" that members of Council were not willing to at least allow an open debate on the issue. Deputy Mayor Ellsworth reminded the Mayor he could have vacated the chair in order to second the motion and allow debate. His Worship the Mayor noted there was no point in vacating the chair since the other members of Council were not willing to support the motion, noting he is not in favour of the Mayor getting into the habit of leaving the chair to second the motion, thereby loosing control over the ensuing debate. He noted one should only have to vacate the chair for an "extremely serious situation".

During discussion, Councillor Collins pointed out that he was satisfied with Council's decision on the Redmond's Road application and saw no reason to further discuss the issue.

Councillor Hann referenced a CBC interview with Councillor Coombs which, he noted, appeared to insinuate that the Development Committee was being politicized because Councillors attend the meetings. Councillor Duff noted that she has been attending the meetings for years, and there is nothing "untoward" with Councilors attending the meeting. Councillor Coombs asked that staff provide information on the mandate of the Committee. He also asked if Councillors enter into debate on the issues brought before the Committee.

# **Councillor Coombs**

Councillor Coombs noted that concern has been expressed to him that some businesses in the downtown are not keeping the sidewalks in front of their business free of snow and ice. It was noted that the City has a cost shared arrangement with the DDC to clear the sidewalks. However, this arrangement is solely for sidewalk snow clearing of 10 cm of snow or more and does not involve salting or sanding.

Councillor Galgay also noted that he received a similar complaint from a downtown business owner. Enforcement of the regulation governing salting and sanding of sidewalks by business owners was questioned and in this regard the matter was referred to staff.

Councillor Galgay referenced the Mayor's attendance January 14, 2009 at the FCM Big Cities Mayors' Caucus in Ottawa, and asked that he take advantage of the opportunity to bring forward the issue of affordable housing along with his list of capital projects, among others.

# **Councillor Puddister**

Councillor Puddister pointed out to members of Council that if the City is to enforce the proper clearing of sidewalks in the downtown it has to be diligent in looking after those owned and controlled by the City.

## **Councillor Hickman**

Councillor Hickman referenced the invitation from the Eastern School District to the 2008-11 Strategic Plan Presentation, January 13, 2009 and offered to attend the meeting on behalf of Council.

## **Councillor Colbert**

Councillor Colbert asked for the following information as it relates to the City's provision of parking enforcement on private parking lots:

- 1. The names and addresses of all businesses/government agencies to which we provide the service.
- 2. A copy of the contract between the parties.
- 3. Are all contracts the same? Do they all operate the same? i.e, permits
- 4. Have we ever refused to provide the service to any business, if so, why?
- 5. The revenue that is generated from each of the lots (if this cannot be established then the total revenue will do)
- 6. The minutes of the meeting when Council approved this arrangement between the private businesses and the City.
- 7. What/who gives us the legal right to provide such a service?

# **Councillor Duff**

Councillor Duff advised the general public that Council met today with the Architect, Mr. Philip Pratt regarding the George Street Redevelopment Study. She noted that it was never intended that the outdoor market be exclusive to farmers but to other vendors/multi-faceted. She noted that Council directed staff to provide information on sequencing the projects, provide cost estimates, and identify potential funding partners. That information, once compiled will be presented to Council at which time they will decide how they wish to proceed.

Councillor Duff also alluded to the importance of placing the issue of Affordable Housing on Federal Radar. She noted there has been a lot of concern across Canada over the years because the Federal government pulled out of its leadership role on Affordable Housing creating enormous deficit. Not only is capital funding needed, but also creative and sustained leadership, and financial investment from the Federal Government. She noted that when the Federal government was involved in such programs the greatest progress was made in making sure all Canadians have access to what is really a basic human right and that is, having decent, affordable housing.

# **Deputy Mayor Ellsworth**

Deputy Mayor Ellsworth noted that sidewalk clearing was raised recently and referred to the Council/DDC/BIA Joint Council.

# His Worship the Mayor

His Worship the Mayor referenced a weekend article by the Telegram regarding a National Freedom of Information Audit. It noted that St. John's ranked third-best out of 22 municipal governments across the country surveyed by the Canadian Newspaper Association, garnering a grade of B. The Mayor commended and thanked staff on their handling of information requests.
