1. Delegation – Dr. Beverley Diamond and Dr. Kati Szego – Memorial University School of Music re: International Council for Traditional Music (ICTM) 2011 Conference

The Committee met with Dr. Beverley Diamond and Dr. Kati Szego to discuss the ICTM Conference being held in St. John's in July 2011 and the possibility of the City providing funding in the amount of \$75,000 for this conference.

Dr. Diamond and Dr. Szego provided the Committee with a brief overview of the ICTM 2011 Conference, noting that this is only the second time that the conference has been held in North America. ICTM 2011 is an academic conference about music and dance traditions throughout the world, which will be followed by a festival of world music. It is anticipated that the conference will be attended by approximately 500 people, from some 50-60 countries. Many of these people will likely come to St. John's early to attend Festival 500 or extend their stay after the conference to take in the Jazz Festival. Dr. Diamond advised that officials with ICTM had visited the Province in June and were impressed with the City's conference facilities, the support of the local organizing committee and the media interest in the conference. Dr. Diamond also outlined the benefits to the City to host such a prestigious conference. In addition to the economic benefits, the City's local musicians and artists will greatly benefit from interactions with conference delegates and exposure to delegates through musical performances scheduled as part of the conference program.

Following the presentation, a brief question and answer period ensued regarding the request for funding and the proposed budget for the conference. Councillor Hanlon inquired if the revenue amounts listed in the budget for various government agencies had been confirmed. Dr. Diamond advised that the funding from MUN, TCR, and ACOA has been confirmed. The requests to Canadian Heritage, SSHRC and the Canada Council are still under review. Councillor Hann expressed concern that a large portion of the budget includes salaries and benefits. Dr. Diamond advised that the figure for personnel and benefits includes salaries being paid to MUN employees who are working on the conference. In addition, there are plans to hire a full-time concert manager, a part-time festival manager, a marketing director, and a technical coordinator. Councillor Hann inquired if any donations had yet been solicited from the corporate sector. Dr. Diamond advised that plans to solicit donations from the corporate sector have recently begun.

(Drs. Diamond and Szego retired from the meeting.)

A brief discussion ensued wherein it was noted that this is a large funding request, and the City has a policy regarding funding for special events and festivals. It was suggested that the matter be referred to the Director of Economic Development, Tourism, and Culture for review and recommendation.

The Committee recommends, on motion of Deputy Mayor Duff; seconded by Councillor Breen: That the festival funding request for the ICTM 2011 Conference be referred to the Director of Economic Development, Tourism, and Culture for review and recommendation as per the criteria used to evaluate special events and festival applications.

2. Capital Grant – Vera Perlin Society

The Committee considered a memorandum dated August 19, 2010, from the Director of Finance regarding the above noted matter.

The Director of Finance advised that in 2007 Council agreed to provide \$250,000 in funding for the renovation and reconstruction project of the Vera Perlin Centre, with the funding to be paid out over a five year period. Due to lack of other sources of funding at the time, the project did not immediately commence and no funds were paid out by the City. The project is now underway, and the Society has contacted the City requesting \$200,000 in funding be paid out covering the years 2007-2010, with the remaining \$50,000 to be paid out in 2011.

A lengthy discussion ensued wherein it was noted that the City will likely run a deficit this year due to the recent capital expenditures approved by Council, and the funding for Vera Perlin has not been allocated in this year's budget. It was agreed that the funding commitment must be honoured, however, it would be difficult for Council to allocate the requested amount from this year's budget. The City's financial commitment should start now, with \$50,000 being paid out this year instead of the requested \$200,000. Councillor Colbert suggested that the Director of Finance contact the Society to determine their cash flow situation and see if they would be amenable to a different payout schedule of slightly higher amounts over a shorter period of time. The City Manager also suggested that the payouts commence next year so that the item can be included as a budgeted expense for 2011.

The Committee recommends, on motion of Councillor Tilley; seconded by Councillor Colbert: That the Director of Finance meet with representatives from the Vera Perlin Society to discuss allocation of the City's \$250,000 commitment, specifically how it can be allocated to best serve the needs of the organization and the City.

3. Employee Wellness Program

The Committee considered a memorandum dated August 16, 2010, from the Director of Human Resources regarding the above noted matter. The Committee also reviewed a Power Point Presentation by the Employee Wellness/Health Educator, which provided an overview of the Employee Wellness Program since its inception. Some of the wellness

initiatives that have been implemented through this program include the Sanitation Stretching Program, Stop Smoking Program, Employee Fitness Program, and Nutrition Policy. When the Employee Wellness Program began, 230 employees initially availed of the services of the Wellness Educators and in the two years following, employee participation has increased to 682 employees to date.

Several members of Council expressed their support for the Employee Wellness Program, noting that improving employee health is beneficial in to the City in the long run as it helps to reduce workplace injuries and sick leave absences. Councillor Breen referenced the benefit management fund of \$1.95 million from which the Employee Wellness Program is funded, and he inquired if the City had given any thought to taking a premium holiday because of the excess in the fund. The Director of Finance indicated that the group insurance premiums are increasing in small increments each year, however, it was felt that it was better to leave the benefit management fund alone on the chance that premiums start increasing in much larger increments. In the event that this happens, then the fund could be used to off set the increased costs.

The Committee recommends; on motion of Councillor Breen; seconded by Councillor Galgay: That the Employee Wellness Program become permanent and that Mr. Bryan Harris be permanently appointed to the position of Employee Wellness Educator.

4. 2011 Fiscal and Service Strategy and Budget Process

The Committee considered a memorandum dated August 18, 2010, from the Director of Finance regarding the above noted matter.

The Director of Finance advised that the 2011 Fiscal and Service Strategy document provides staff with the background and details necessary for preparing their budgets. The deadline for Departmental budget submissions is September 7th. There will be a change in the water taxes rates in 2011 to reflect the financing and operation of the new Waste Water Treatment Facility, and the Provincial Government has confirmed that the City's Municipal Operating Grant for 2011 will remain at \$3.1 million. The Director of Finance noted that some of the increases in operating expenses for 2011 can be attributed to increased employee salaries through union contract negotiations, and full year operation of the Waste Water Treatment Facility and the Recycling Program. Once the draft operating budget has been prepared, it will be reviewed by the various Standing Committees as Committees of the Whole, with the final review and ranking to be done via the Finance Committee (Committee of the Whole) prior to December 8th.

Deputy Mayor Duff inquired about the plans for public budget consultations as previously discussed by the Committee. The Director of Finance noted that he had previously presented a report on this subject for the Committee's consideration in January of this year, and he indicated he could bring the matter forward again for further review. The City Manager suggested that the report be brought to a Special Meeting of Council for further consideration.

On-Line Registration – Recreation Program

Council considered as information a memorandum dated September 7, 2010 from the Acting Director of Recreation regarding the above noted.

Economic Update – September 2010

Council considered as information the September 2010 Economic Update. Councillor Hanlon reviewed the report which noted that a recent survey says St. John's has the lowest vacancy rate for both office and industrial space and the highest rental rates in Atlantic Canada. Another survey by Turner Drake and Partners Ltd. found that Class A office space is now fully occupied.

Councillor Hann commented on the availability of Class A office space and the need for the City to arrive at a consensus on how to approach development while at the same time maintaining the heritage and character of the City. Councillor Hann referenced a recent Telegram Article by Mr. Derek Sullivan, Chair, St. John's Board of Trade, titled "Building up St. John's".

His Worship the Mayor encouraged all members of Council to read the article, noting that the Board of Trade acknowledges the challenges the City is facing on the issue of development in the City noting it is up to all parties to make it happen.

Councillor Galgay commended Mr. Sullivan on the article. He listed a number of new developments the City has supported and praised the City on doing a commendable job in balancing development with the historic ambience.

Deputy Mayor Duff indicated that the economic road maps are a very interesting exercise, and an economic summary because it provides useful information. She noted that though the City has an economic opportunity for its tax base, an escalation in the cost of living and housing impacts the student population; lower income population; seniors, many of whom are moving into that fixed income category.

In referencing Mr. Derek Sullivan's article, she noted she was impressed with the way he has been communicating and reaching out to the community. She pointed out that the Smart Group, whose interest is in good urban development particularly as it relates to downtown, made that initial approach to Mr. Sullivan.

On the issue of the Class A office space, she questioned how Class A office space is defined. She noted it should be recognized that the City will very soon be opening a 100,000 square foot Class A office space development at the old Littledale complex, and further, that the City agreed to a zoning change to remove the block west of Steers Cove out of the heritage conservation area to provide for the additional densities that Class A office space would need. She noted that the 15 metre height requirement was put in place in small conservation areas to encourage the adaptive reuse of existing buildings, indicating the City needs to create other kinds of uses that will balance and keep the character of the downtown and its tourist attraction. She noted she is looking forward to continued dialogue with the Board of Trade.

Letter dated August 31, 2010 from Chief of Police, Mr. R.P. Johnson, thanking Council and the citizens of St. John's for conferring upon the RNC the "Freedom of the City"

Council acknowledged the above noted letter.

The Bowring Park Master Plan

Council considered a memorandum dated September 1, 2010 from the City Manager regarding the above noted.

SJMC2010-09-07/501R

It was moved by Councillor Hann; seconded by Councillor Collins: That the City provide \$120,000 towards one of the phases of the implementation of Bowring Park Master Plan adopted by Council; the total cost estimated to be \$240,000 of which \$120,000 will be contributed by the Foundation.

The Acting Director of Public Works and Parks presented a diagram of the changes proposed which involves the realignment of the roadway on the north side of the Bungalow and its conversion into a pedestrian walkway only; the installation of an electronic control arm at the east entrance of the Park near the Lodge; the refurbishing and upgrading of all the trails on the north side of the park, including those which lead to the Caribou and the Beaumont Hamel Plaques; and the widening and repaving the south side of the present loop around the Bungalow.

During discussion, the Deputy Mayor suggested that staff look at incorporating a cycling lane before finalizing the proposed design. Council concurred.

Following discussion, the motion being put was unanimously carried.

Deputy Mayor Duff

Deputy Mayor raised the situation with respect to flooding disaster in Pakistan and noted that the local Pakistanian Community are arranging a fundraising event to aid the flood victims, and encouraged members of Council and the community at large to come out in support of the victims at this difficult time.

Councillor O'Leary

Councillor O'Leary offered condolences to the family of the late Ann Marie Shirran.

- 23 - 2010-09-07

Councillor O'Leary advised residents there will be an Open House of the City's Animal Care and Adoption Centre located at 81 Higgins Line (adjacent to the Howley Building) from 2:00 to 4:00 p.m. on Sunday, September 12th, 2010.

Councillor O'Leary mentioned information in relation to the City of Toronto's financial support to artists, and a group called "Art Vote" who lobbied the City of Toronto who subsequently voted in August to increase their art funding to \$25 per capita by 2013. She noted she intends to raise the issue with the Arts Advisory Committee to advocate for increased support from the City.

Councillor Hann

Councillor Hann advised that Metrobus Transit is conducting a comprehensive review of public transit in the greater St. John's area, and as part of this review, public input is being sought. A public meeting will be held in the E. B. Foran Room at St. John's City Hall at 7:00 p.m. on Tuesday, September 14th, 2010.

Councillor Hann expressed concern over the decline in Federal presence in the form of employment not only in the City but throughout the Province. He noted as well a significant decline in Military presence. His Worship the Mayor noted that he has asked the Department of Tourism, Culture and Economic Development to carry out an analysis of the impact of that decline and will take appropriate action once the information becomes available.

Councillor Colbert

Councillor Colbert advised residents that the boarding being installed along the Boulevard is due to the construction of the DND building, in order to protect the threat to the trees and banks along the area.

Councillor Colbert noted the lack of road lines on newly paved areas, and asked if temporary lines could be installed in heavy traffic areas in the interest of public safety. The matter was referred to the Director of Public Works and Parks for followup.

- 24 - 2010-09-07

Councillor Breen

Councillor Breen advised that the consultant's report on the East End Odor problem should be available by the end of this month.

Councillor Breen advised that Habitat for Humanity project on Charter Avenue is running into labour problems due to lack of volunteers. He made a plea especially to specialized trades people to consider volunteering some of their time towards the project.

Councillor Galgay

Councillor Galgay advised of a public hearing to be conducted by an Independent Commissioner appointed by Council to consider St. John's Municipal Plan Amendment Number 85, 2010 and St. John's Development Regulations Amendment Number 489, 2010 to be held on Wednesday, September 15, 2010, beginning at 7:00 PM in the Foran/Greene Room, 4th Floor, City Hall.

Councillor Tilley

Councillor Tilley advised that a meeting was held with the developer regarding the proposed Diamond Marsh Subdivision and another is pending. He noted a final decision on the proposed development will be made within the next few weeks.

Councillor Hanlon

Councillor Hanlon tabled a letter from Mr. J. F. Cull regarding a traffic issue on Stamp's Lane and Freshwater Road and asked that it be referred to the Police and Traffic Committee for follow-up.

Councillor Hanlon commended members of the cast of The Republic of Doyle on their nominations for Gemini Awards.

Councillor Hanlon advised that she along with Councillor Tilley met with members of the Newfoundland and Labrador Home Builders Association concerning construction guidelines etc. and will continue to negotiate with them on the issues.

- 25 - 2010-09-07

She tabled information which can be obtained at the City's Access Centre, City Hall.

Councillor Hanlon noted that the City is creating a Strategic Economic Roadmap to help guide the City's economy for the next ten years, and is anticipated to be completed by 2010.

Councillor Hanlon also tabled the State of the Economy – St. John's Metro, Report, which she noted can be accessed online. She commended staff on their work in the preparation of the report.

Councillor Collins

Councillor Collins indicated that he has received complaints from residents of Southlands that contractors are leaving garbage in the area. He asked that the matter be referred to staff for followup.

His Worship the Mayor

His Worship the Mayor noted concern over safety incidents with flag personnel working on various job sites. He asked people to be very mindful of those workers when approaching the various job sites.
