### **Economic Review 2021**

The St. John's metro economy saw signs of recovery in 2021. Real gross domestic product (excluding oil and gas extraction) increased by 7%, as many private sector service industries rebounded. Retail sales were up 9.0% to \$4.3 billion in 2021 as consumer spending returned to pre-pandemic levels. There was an increase in residential activity with housing starts increasing 30% mainly due to low mortgage rates and pent-up demand. <u>Read the full report</u>.

## **News Briefing**

#### St. John's CMA adds 4,161 residents since 2016 census

According to the latest census population data released by Statistics Canada, the City of St. John's population increased 1.4% between 2016 and 2021 to 110,525. In 2021, there were 49,298 dwellings in St. John's, representing an increase of 3.5% from 2016.

The St. John's Census Metropolitan Area (CMA), comprised of the communities listed below, saw its population grow by 2% to 212,579 over the five-year span. In 2021, dwelling counts rose by 4,984 units over the same period to 89,999 dwellings from 85,015 in 2016, representing an increase of 4.7%.

By the numbers, here is what the 2021 census shows for St. John's CMA municipalities:

• Paradise grew to a population of 22,957 from 21,389, a growth rate of 7.3%.

• Logy Bay-Middle Cove-Outer Cove grew to a population of 2,364 from 2,221, a growth rate of 6.4%.

- Bay Bulls grew to a population of 1,566 from 1,500, a growth rate of 4.4%.
- Conception Bay South grew to a population of 27,168 from 26,199, a growth rate of 3.7%.

• **Portugal Cove-St. Philip's** grew to a population of 8,415 from 8,147, a growth rate of 3.3%.

- Flatrock grew to a population of 1,722 from 1,683, a growth rate of 2.3%.
- St. John's grew to a population of 110,525 from 106,364, a growth rate 1.4%
- Witless Bay grew to a population of 1,640 from 1,619, a growth rate of 1.3%.
- Holyrood grew to a population of 2,471 from 2,463, a growth rate of 0.3%.
- Pouch Cove fell to a population of 2,063 from 2,069, at a decline of -0.3%.
- Torbay fell to a population of 7,852 from 7,899, at a decline of -0.6%.
- **Petty Harbour-Maddox Cove** fell to a population of 947 from 960, at a decline of 1.4%.

- Mount Pearl fell to a population of 22,477 from 23,120, at a decline of -2.8%.
- Bauline fell to a population of 412 from 452, at a decline of -8.8%.

#### NL Corporations Act removes residency requirement

On April 1, 2022, changes to the **Newfoundland and Labrador Corporations Act** will take effect. One of the amendments removes the requirement that 25% of directors of corporations be Canadian residents. This change is consistent with the majority of Canadian provinces, and is particularly beneficial to international corporations seeking to do business in Newfoundland and Labrador (NL) that might, at the outset, lack local contacts to fill director positions. Currently, such businesses often choose to incorporate in another Canadian jurisdiction without the Canadian residency requirement, and extra-provincially register in NL, adding time and cost to the process. When the changes take effect on April 1, this will no longer be necessary, making it easier for such corporations to do business in Newfoundland and Labrador.
