### WHAT DO CROSSING GUARDS DO?

- RESPONSIBLE FOR THE SAFETY OF CHILDREN CROSSING BUSY STREET INTERSECTIONS.
- MAINTAINS A PLEASANT, COURTEOUS, AND HELPFUL ATTITUDE TOWARD THE SCHOOL CHILDREN AND THE GENERAL PUBLIC AT ALL TIMES.
- ESCORTS CHILDREN ACROSS THE STREET AT DESIGNATED CROSSWALK LOCATIONS USING DUE CAUTION AND DISPLAYING A CROSSING SIGN.
- PREVENTS CHILDREN FROM CROSSING THE STREET DURING FLOW OF TRAFFIC ON STREET UNTIL IT IS SAFE TO CROSS.
- REPORTS ANY DANGEROUS DRIVING OR CROSSING PRACTICES, OR PROBLEM CONDITIONS AND/OR BEHAVIOURS TO THE APPROPRIATE AUTHORITY.
- ESTABLISH AND MAINTAIN EFFECTIVE RELATIONS WITH SCHOOL CHILDREN AND THE PUBLIC.
- PERFORMS RELATED TASKS AS ASSIGNED.

### DO I GET PAID?

THE RATE OF PAY FOR THESE POSITIONS IS BETWEEN \$11.34 TO \$12.63 PER HOUR AND WILL CONSIST OF 2-3 HOURS PER DAY TO COINCIDE WITH SCHOOL ASSEMBLY AND DISMISSAL TIMES.

### WHAT ARE THE QUALIFICATIONS?

- MUST HAVE A VALID DRIVER'S LICENSE AND RELIABLE TRANSPORTATION.
- ABILITY TO WORK WITH CHILDREN ON A DAILY BASIS. ABILITY TO LEARN AND APPLY TRAFFIC REGULATIONS, ESPECIALLY THOSE PERTAINING TO PEDESTRIAN CROSSWALKS.
- MUST BE ABLE TO COMMUNICATE CLEARLY AND EFFECTIVELY.
- MUST MAINTAIN A CLEAN AND NEAT APPEARANCE.
- ABLE TO PERFORM DUTIES IN INCLEMENT WEATHER.
- APPLICANTS WILL BE REQUIRED TO PROVIDE A RNC CERTIFICATE OF CONDUCT.
